Early Childhood LETRS Training Reminders

Cohort 1 Pre-K teachers and site administrators have until **October 31, 2022** to complete their online course.

Cohort 2 Pre-K teachers and site administrators have until **January 31, 2023** to complete their online course.

These courses will no longer be available after these dates. Completing the online course is required. If you have any questions please contact your local NC Pre-K contracting agency and/or the school district LETRS point of contact.

As you are registering for upcoming LETRS sessions, please select times that you are not supervising children. It should be a time you are free to focus and learn for application purposes.

LETRS® Training Plan for Non-Public School NC Pre-K Lead Teacher and Administrator New Hires - Cohorts 1 & 2

The Department of Public Instruction and the Department of Health and Human Services have collaborated to develop a plan for sustaining LETRS® for Early Childhood Educators training for newly hired lead NC Pre-K teachers and site administrators in childcare and Head Start settings (not operated by public schools).

Twice per year, in August/September and December/January, DPI will send a survey to all NC Pre-K contracting agencies (Contract Administrator and Program Contact) requesting information about newly hired lead teachers and site administrators. Once this data is gathered, DPI will provide the information to Lexia. Beginning the first week of December, Lexia will ship print materials directly to the participants' sites and participants will be enrolled into the online course.

DPI will provide a training calendar and offer the live facilitated LETRS® for Early Childhood Educators training each month beginning in December 2022, so that this component of the training program is available at no additional cost to programs.
