SUPT'S EMAIL: Update on 2019-2020 Federal Program Monitoring Schedule for Title IX, Part A, the Education of Homeless Children and Youth Program (McKinney-Vento)

This email revises the information about federal program monitoring of Title IX, Part A, the Education of Homeless Children and Youth Program (McKinney-Vento), for the 2019-2020 academic year that was released in a Superintendent's Email on January 13, 2020.

As Governor Northam has ordered schools to remain closed for the remainder of the academic year, all 2019-2020 federal program monitoring of school divisions' homeless education programs not completed prior to March 23, 2020, will be cancelled. Those divisions scheduled for visits later this spring will be prioritized for monitoring in 2020-2021.

School division homeless education liaisons are doing the work that needs to be done to serve our students experiencing homelessness and their families. That work should remain the priority during the COVID-19 crisis.
