Report Highlights:

On April 15, 2021, the second stage of Kazakhstan's 2021 meat quotas were announced by the Kazakhstani Ministry of Trade and Integration. The decrees approve the remaining tariff quotas for certain types of meat and poultry products for 2021, per specific importer, and came into force the day it was signed.

General Information:

Starting from January 1, 2010, tariff rate quotas (TRQs) were introduced for Belarus, Kazakhstan, and Russia by Customs Union Commission Decision No 130 dated November 27, 2009. Since then, the Customs Union Commission, and later the Eurasian Economic Union Commission, approved specific TRQ volumes for beef, poultry, and pork for member counties. For more information, please, refer to GAIN "Eurasian Economic Commission Published 2021 TRQ" Report. Kazakhstan, in turn, approves specific volumes of beef and poultry per specific importer, who is authorized to import the product under the preferential customs rate of 15 percent of customs value for beef and 25 percent, but not less than 0.2 Euros per kilogram, for poultry. Any beef imported outside of the quota is assessed a duty rate of 50 percent of the customs value but not less than 1 Euro per kilogram. Any poultry imported outside of the quota is assessed a duty rate of 80 percent of the customs value, but not less than 0.7 Euro per kilogram. Beef and poultry meat are still under TRQ regimes, whereas pork quotas were cancelled in 2016. In 2020, the TRQ for beef was filled at 38 percent and poultry at 80 percent.

The first stage for Kazakhstan's 2021 meat quotas was approved in December 22, 2020. Please see First Stage 2021Meat TRQs for Kazakhstan KZ2021-0006 GAIN report for more details. On April 15, 2021, the second stage of Kazakhstan's 2021 meat quotas were announced by the Kazakhstani Ministry of Trade and Integration. The decrees approve tariff quotas for certain types of meat and poultry products for 2021, per specific importer, and came into force the day it was signed.

BEGIN UNOFFICIAL TRANSLATION

Order of the Minister of Trade and Integration of the Republic of Kazakhstan No 280-NK, April 15, 2021 Tariffs Quota Rates Distribution

In accordance with part two of <u>Article 16-1</u> of the Kazakhstan Trade Regulatory Act, the Eurasian Economic Commission's <u>Decision</u> of 18 August 2020 No. 102 "On the establishment of tariff quotas for certain agricultural products for 2021, the Eurasian Economic Union, as well as the volumes of tariff quotas for these goods imported into the territory of the member states of the Eurasian Economic Union," **THE ORDER:**

1. Distribute the volume of tariff quotas between historical suppliers for 2021 (2nd stage) according to the annex to this order.

- 2. The Department of Internal Trade of the Ministry of Trade and Integration of the Republic of Kazakhstan to ensure that this order is placed on the Internet resource of the Ministry of Trade and Integration of the Republic of Kazakhstan.
- 3. Overseeing the implementation of this order should be placed on the supervising Vice-Minister of Trade and Integration of the Republic of Kazakhstan.
- 4. This order comes into force from the day it is signed.
