#### **Return to School Resources**

As PSUs begin a new school year, student-centered decisions remain critical to the continuing transition from remote to in-person learning and summer learning opportunities to a new school year. Assessing gaps in learning and determining ongoing recovery services will continue to be a primary focus of problem-solving teams. To further clarify differences between "compensatory services", also known as recovery services, and "compensatory education", the remedy for a denial of FAPE, a new resource has been posted in the COVID-19 Padlet titled: Post Pandemic "Compensatory Services" by Perry A. Zirkel. This resource affirms previous guidance provided by the EC Division and continues to clarify the difference between the two terms and problem-solving necessary, in light of learning gaps experienced by all students.

Secondly, the Department of Education released *Volume 2: ED COVID-19 Handbook* in April 2021. While previously highlighted, we are re-sharing this information as Section II: Addressing Lost Instructional Time remains current and relevant.
