If your district does not certify the data required for Indicators by the due date, your data may be certified by state staff. The integrity of the data is always at risk when the Department of Public Instruction must finalize the data for your district.

#### **Grant Information**

#### • IMPORTANT: IDEA Grant Deadline

All IDEA Initial Grant applications still pending must have the corrections submitted and the initial grant approved by November 30, 2021. Fiscal Monitors will communicate with the EC Directors the specific areas needing attention to complete the IDEA grant submissions. Upon receiving approval of the initial grant application, PSUs will have fourteen days to submit the 2020-2021 MOE. Newly opened charter schools will receive training for IDEA grant application in December and notification of IDEA grant deadline during the training.

#### Maintenance of Effort (MOE)

The MOE Expenditure Table was due by October 31, 2021, for PSUs with approved IDEA grants. The MOE Expenditure Table is a federal requirement, and the grant will remain open for late submission. If you were

unable to attend the MOE training or if you need a refresher, the recording, along with the PowerPoint, are available on the Exceptional Children website <a href="here">here</a> and on the NC CCIP Home Page. If you have questions, please contact your fiscal monitor.

#### Special Grants

Special grants, with the status of Chief Administrator Approved, are reviewed monthly after the 15th. Notification of review is made through NC CCIP. For your review, the Special Grants Training recording, along with the PowerPoint are available on the EC Website here under the Special Grants section.

Please ensure that budget and grant use of funds align to ensure timely approvals.

#### • IDEA/ American Rescue Plan Act of 2021 (ARP)

The American Rescue Plan funds have been allotted under the following Program Report Codes. The budgets will be submitted the same way as the IDEA budgets. A new application is not required.

### PRC 185 IDEA/American Rescue Plan Act of 2021 (ARP) Basic – 611

The funds will align with the IDEA Section 611 Use of Funds. If the funds are budgeted for items not currently in the Section 611 Use of Funds, the Use of Funds must be revised.

## PRC 186 IDEA/American Rescue Plan Act of 2021 (ARP) Preschool - 619

The funds will align with the IDEA Section 619 Use of Funds. If the funds are budgeted for items not currently in the Section 619 Use of Funds, the Use of Funds must be revised.

#### PRC 187 IDEA/American Rescue Plan Act of 2021 (ARP) CEIS

For PSUs with mandatory CEIS, the funds will align with the CEIS Use of Funds. If the funds are budgeted for items not currently in the CEIS Use of Funds, the Use of Funds must be revised.

For PSUs with an approved IDEA grant and needing a grant revision, it should be submitted at the same time as your MOE Expenditures. Contact your fiscal monitor for additional information regarding the IDEA grant status and the submission of the budgets.

- Allotments can be seen on the allotment page of the IDEA Grant in CCIP
- Budgets are submitted through each PSU's budgeting system and will be pulled into CCIP
  - o Directors/Coordinators can view the budgets once submitted by clicking on the budget link on the IDEA Grant Sections page
  - o The funds can be utilized on any IDEA allowable expense. The Chart of Accounts now contains the allowable budget codes for PRC 185, 186 & 187. It can be found here:

- If the budget aligns with the current Section 611/619 and or CEIS Use of Funds, the IDEA Grant does not need to be revised.
- If the budget includes line items not currently in the Section 611/619 or CEIS Use of Funds, the IDEA Grant must be revised to include the new line items. Designate in the Use of Funds that the revision items are for PRC 185/186/187.
  - o Example: Current Use of Funds does not include funds for professional development. Add to the Use of Funds:

- Revision for PRC 185: Professional Development Workshop Expenses
- After the IDEA Grant and all related budgets are approved, SPD notifies NCDPI School Business. SPD does not allot the funds or know when the funds will be allotted.

## **Updated Resource: Required Screening/Evaluations for Eligibility**

The monitoring consultants have routinely provided this one-page resource to support EC staff in quickly identifying the required screening and evaluations for suspected disabilities. This resource has been updated to clarify observations and evidence-based interventions as it relates to specific disability categories. ## **Medicaid Presence Removed from ECATS**

After a year-long effort, all Medicaid functionality has been removed from the ECATS Service Documentation module and the ECATS training site. This includes the removal of Medicaid-relevant reports and storage/tracking of Medicaid One Time Consent & Physician Authorization forms/prompts. Relevant ECATS training materials, videos, guides, and manuals have been updated to reflect these removals, which are summarized in the table below.

# Medicaid Considerations for the End of the Public Health Emergency (PHE), January 16, 2022

In March, 2019, the NC Division of Health Benefits (DHB, NC Medicaid) added flexibility to <u>Clinical Coverage</u> <u>Policy 1-H</u> – NC Medicaid Telehealth, Virtual Communications and Remote Patient Monitoring. Subsections 1, 3, and 5 of this policy apply to NC PSUs. The federal public health emergency driving these flexibilities will end on January 16, 2022. PSUs with Medicaid claiming programs will want to prepare. The anticipated changes and/or enforcements to telehealth services that may impact NC schools are as follows:

- Section 3.2.1 (f) "Provider(s) shall obtain and document verbal or written consent" to provide telehealth services and
  - (h) "Provider(s) shall verify the beneficiary's identity using two points of identification before initiating service delivery via telehealth"
  - The expectation is that PSUs are documenting consent prior to delivering telehealth services, unless there are "extenuating circumstances when consent is unable to be obtained, this must be documented."
  - The expectation is that LEAs are documenting 2-point identification before initiating services at each telehealth session.
- Section 5.3.1 "All telehealth services must be provided over a secure HIPAA compliant technology..."
  - There was a relaxation of this during the COVID national emergency; policy 1H guidelines will apply once the PHE has expired.

#### **Extended Content Standards for Social Studies 2nd Public Comment Period**

Alternate academic achievement standards set an expectation of performance that differs in complexity from a grade-level achievement standard. ESSA permits states to develop alternate academic achievement standards for students with significant cognitive disabilities. In North Carolina, these alternate academic achievement standards are known as the Extended Content Standards. The North Carolina Department of Public Instruction, Exceptional Children Division convened stakeholder groups to create, and review proposed extended content standards for Social Studies for students with significant cognitive disabilities. The Extended Content Standards for Social Studies are open for the second public comment period from November 4 to December 7, 2021.
