SUBJECT: SKID ROW ACTION PLAN: IMPROVING THE

LIVES OF RESIDENTS ON SKID ROW BY ADDRESSING HOMELESSNESS STEMMING FROM DECADES OF INSITUTIONAL RACISM (ITEM 17, FROM THE AGENDA JUNE 28, 2022)

On June 28, 2022, the Board of Supervisors (Board), directed the Department of Health Services' Housing for Health (HFH) in conjunction with the Chief Executive Office Homeless Initiative (CEO-HI) to convene working groups that include representatives from the City of Los Angeles Mayor's Office, Los Angeles City Council District 14, the Los Angeles Homeless Services Authority (LAHSA), Department of Public Social Services, Department of Mental Health, Department of Public Health, Los Angeles County Department of Aging and Disabilities, Los Angeles County Department of Economic Opportunity, and Skid Row community partners including residents, service providers, and stakeholders, to develop a collaborative Skid Row Action Plan. The working groups were directed to work together to leverage existing resources to support the action plan. This is the final report from HFH.

Attached, please find the Skid Row Action Plan (SRAP) recommendations (**Attachment A**).

As stated in previous reports, Dr. Alisa Orduña and HFH staff facilitated a total of 15 workgroup meetings from August 2022 through November 2022 in the following categories:

- Permanent Housing
- Safe Services
- Interim Housing
- Drug-User Health Hub
- 24/7 Low Barrier Health and Behavioral Healthcare Center

In addition, the CEO-HI facilitated two meetings with the City of Los Angeles (LA City) and two meetings with the applicable Los Angeles County (LA County) departments and LAHSA.

These meetings brought together community members, local organizations, service providers, LA City and LA County departments, and other stakeholders which informed the attached SRAP recommendations. In addition, a Skid Row Resident Advisory Committee also guided SRAP's development.

On November 18, 2022, the Skid Row Resident Advisory Committee hosted a festival for the community to review draft recommendations, provide feedback, and identify priorities in each workgroup category. On December 14, 2022, a final meeting with stakeholders and contributors was conducted to present the groups' recommendations.

The next steps include HFH working with CEO-HI to develop cost estimates and to identify potential funding sources to address each of the recommendations. It is anticipated that this work will take two to three months.

# SKID ROW ACTION PLAN: IMPROVING THE LIVES OF RESIDENTS ON SKID ROW BY ADDRESSING HOMELESSNESS STEMMING FROM DECADES OF INSITUTIONAL RACISM (ITEM 17, FROM THE AGENDA JUNE 28, 2022)

Skid Row is a community whose residents care deeply about their neighborhood and who strive daily towards health and safety for all who reside there. The Skid Row Action Plan aims to address the history of Skid Row, which sits at the crossroads of historic and systemic racism and deep poverty. Since the end of the 19<sup>th</sup> century, housing scarcity and unaffordability throughout Los Angeles brought those experiencing financial and housing insecurity to the area's affordable, low-barrier housing. To begin to redress the harmful impacts of history, the Skid Row community is seeking investment and resources to build up the community to a place of thriving.

On June 28, 2022, the Board of Supervisors passed a motion introduced by Supervisor Solis to create a Skid Row Action Plan to outline recommended priorities for transitioning Skid Row into a safe and healthy community. The motion laid out several components to be included in the plan including increasing permanent and interim housing, creating a safe services space, a 24/7 health and behavioral health center, and a drug user health hub. The motion requested that the Department of Health Services Housing for Health (HFH) in conjunction with the CEO Homeless Initiative lead a stakeholder process to collectively develop the Skid Row Action Plan. HFH developed five workgroups in line with the five priorities outlined in the motion, as well as a Skid Row Advisory Council and a government workgroup, convening service providers, county and city staff, Los Angeles Homeless Services Authority (LAHSA) staff, local residents, and persons who are accessing or have accessed services in the community.

These community contributors to the Skid Row Action Plan are advocating firmly for a shift away from inflexible service models or enforcement activities, and towards a public safety achieved through the empowerment of community members to promote community cohesion. As a result of the policies which have shaped Skid Row, Black, Latino and LGBTQ+ communities are prominently represented in the Skid Row population, and residents are clear: the services meeting the needs of the Skid Row population must culturally reflect the communities they are serving. The workgroups developed recommendations for a throughline of values for Skid Row operation, as well as tangible programs, processes, and spaces which will realize this vision for the neighborhood.

#### **GOVERNING PRINCIPLES**

Throughout its development and operation, the Skid Row Action Plan must be governed by the goals to:

- Provide all housing and services through trauma-informed practices and in a culturally aware manner, in recognition of the specific community culture of Skid Row.
- Develop services and infrastructure with particular attention to the most vulnerable Skid Row populations, including severely mentally ill individuals, substance users, sex workers, families, undocumented individuals, women, and members of the LGBTQ+ community.
- Develop housing and service spaces which are welcoming and designed with an eye towards positivity, tranquility, warmth, and trust.
- Employ and develop well trained, compassionate, non-judgmental staff who are invested in the wellbeing and nurturing of Skid Row and community members.

#### PERMANENT HOUSING

The Skid Row Community expressed significant concerns regarding the wellness of existing permanent housing in Skid Row. The workgroup discussed the difficulty of transferring to other housing opportunities based on changes in life circumstances such as aging-in-place. Individuals who are currently housed in Skid Row permanent housing units unilaterally report unsafe, unhealthy, and poor living conditions. In addition, they feel as though they are not treated kindly by property management and that there is a lack of opportunity to build a sense of community and belonging among tenants, creating feelings of isolation and mistrust. This results in feelings of powerlessness and hopelessness of the tenants, which undermines the social value of housing as a place that people could proudly call home.

#### **INTERIM HOUSING**

The Skid Row Community needs more interim housing beds that are easily accessible and low-barrier. Multiple types of interim housing are necessary, meeting the various needs of the unhoused Skid Row Community. Workgroup members, particularly those with experience of interim housing in Skid Row, spoke of the trauma of losing a bed for being in noncompliance with a host of provider rules and guidelines.

## 24/7 LOW BARRIER HEALTHCARE CENTER

The Skid Row Community needs 24/7 access to healthcare resources which is low-barrier and is set up to treat all residents of Skid Row. This Center should offer critical services for those in crisis and those seeking a low-barrier entrance into preventative and ongoing medical care.

#### **DRUG USER HEALTH HUB**

Skid Row is experiencing an acute overdose crisis that demands a rapid response. These deaths and the many non-fatal overdoses exacerbate trauma experienced by the Skid Row community. The Drug User Health Hub provides a holistic approach to supporting people who use drugs, supporting them to reduce harm in their lives and improve Skid Row community health. This model requires a relational approach to people who engage in services, supporting their self-defined health and wellness goals. The Health Hub would provide accurate, relevant health education, naloxone/ overdose prevention and safer consumption and safer sex supplies as well as linkages to programs and services for those seeking treatment.

#### **SAFE SERVICES SPACE**

The Skid Row community needs a safe and inclusive low-barrier space which provides services and programming for the entire Skid Row Community. Services would include intensive care for vulnerable populations including mentally ill individuals, substance users, families, undocumented individuals, women, and members of the LGBTQ community. Safe services should build from what already exists in Skid Row and should incorporate and empower the voices and people of the Skid Row Community in the planning, implementation, and maintenance of the site.
