Program Description

Overview

NIJ seeks proposals for funding to conduct an expansion or extension of one or more ongoing/existing longitudinal research studies that focus on delinquency and crime throughout the life-course of the individual, which may include childhood, adolescence, and young adulthood. Applicants are encouraged to adopt a holistic approach to the study of child and adolescent development and the emergence, persistence, and desistance of delinquent and criminal offending. The research findings are intended to identify malleable risk and protective factors, which can be effectively targeted in efforts to prevent the onset of delinquency and to intervene in the lives of juvenile and young adult offenders.

Applications proposing research involving partnerships with criminal justice or other agencies, should include a strong letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through this project will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review the NACJD's policies and protections at (<u>NACJD</u>). If selected for award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2022. That formal agreement must include a provision to meet the data archiving requirements of the award.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients.

Statutory Authority

Any awards under this solicitation would be made under statutory authority provided by a full-year appropriations act for FY 2021. As of the writing of this solicitation, the Department of Justice is operating under a short-term "Continuing Resolution;" no full-year appropriation for the Department has been enacted for FY 2021.

Specific Information

Life-course longitudinal research provides valuable insights as to the process of adolescent development and transition into adulthood particularly with regard to the prevention, onset, persistence, escalation, and desistance of delinquent and criminal behavior. In keeping with the goals of the Juvenile Justice and Delinquency Prevention Act of 2018, it is essential to identify the risk and protective factors for delinquency involvement in order to inform and advance effective prevention and treatment of juvenile delinquency.

With this solicitation, NIJ seeks to build upon past research efforts to inform our understanding of how better to prevent the onset of, and to encourage desistance from, delinquency, and crime. The Office of Juvenile Justice and Delinquency Prevention (OJJDP) has previously supported a number of major longitudinal studies of delinquency including the Philadelphia Birth Cohort studies,¹² the Seattle Social Development Project,¹³ the Program of Research on the Causes and Correlates of Delinquency (including Denver, Pittsburgh, and Rochester studies),¹⁴ Pathways to Desistance,¹⁵ the Northwestern Juvenile Project,¹⁶ the Crossroads Study,⁷⁷ and the Pittsburgh Girls Study.⁸¹ Currently, NIJ is supporting several initiatives including longitudinal research that focuses on: intergenerational influences under the Northwestern Juvenile Project and Rochester Youth Development Study; extended follow-up into young adulthood of the Crossroads Study sample of youth offenders; extended collection of individual criminal histories for the multi-cohort sample of children first, studied in 1995 under the Project on Human Development in Chicago Neighborhoods;¹⁹ delinquency and

Page 6 of 29 O-NIJ-2021-45005 victimization under the Adolescent Brain Cognitive Development Study;^[10] trajectories and turning points related to delinquency and crime among juvenile justice-involved females in Oregon;^{11]} and root causes of school violence with examination of the interrelationships among factors at the school, family, individual, and community levels under the Comprehensive School Safety Initiative.^{12]} A solicitation for Longitudinal Research on Delinquency and Crime was previously released by NIJ in fiscal years 2019 and 2020.

Overall, research supports the conclusion that no single cause accounts for all delinquency, but rather more serious offending is often associated with children and youth being exposed to multiple risk factors. There is also no single pathway or developmental progression taken by youth as they experience the emergence of, persistence in, and desistance is from delinquency and crime. Individuals vary in terms of the age of onset, and the frequency, severity, and duration of delinquent and criminal careers. Researchers have made considerable progress in terms of hypothesizing and testing various trajectories of youth involvement in delinquency and crime. Researchers have also examined how youth are impacted by their involvement in the juvenile justice system, is and what life transitions, turning points, and changes in sense of self or identity are associated with desistance and other positive outcomes.

Study Methodologies:

- Applicants should clearly describe the existing or ongoing longitudinal study that would be expanded or extended under this solicitation, with a discussion of the existing or original research questions, sample (size, selection criteria, demographics, and attrition to date), data sources and access agreements, data collection to date, study variables and measures, data analysis, findings to date, and associated publications/reports to date.
- Applicants should articulate why this particular existing or ongoing longitudinal study provides a sound basis for investigation of developmental and life-course crime and delinquency in relation to this solicitation's potential expansion/extension.
- Applicants should demonstrate an understanding of relevant research efforts to date, and justify how the proposed study would contribute to our understanding of how effectively to prevent delinquency and to intervene in the lives of youth offenders.
- Applicants should clearly describe how the expansion/extension effort would enhance the current study. As an example, this might entail additional research questions, primary data collection on additional variables, identification of additional data sources, extended number of waves of data collection, enlargement of the sample, examination of extended developmental periods or intergenerational influences on risk and protective factors, additional analysis, increased generalizability of findings, and/or increased utility of findings for policy and practice.
- Applicants are encouraged to approach the etiology of delinquency and crime from a multi-disciplinary perspective, recognizing the holistic development of the child and adolescent in the context of the family, school, peers, and community influences.
- · Applicants are encouraged to incorporate an examination of topics such as the

effects of trauma, child sexual abuse/exploitation, and runaway experiences on the risk for further victimization and/or delinquency and crime.

- In order to guide the selection and inclusion of factors to be investigated, applicants should articulate a theoretical framework. Emphasis should be placed on the identification of malleable risk and protective factors in order for this research to inform the design of more effective strategies for both prevention of, and intervention in, delinquent and criminal behavioral trajectories.
- Under this solicitation, NIJ emphasizes that the expansion or extension of an ongoing study will include prospective data collection to advance our knowledge of developmental and life-course engagement in delinquency and crime. In addition, applicants may also seek to harvest administrative data sources, particularly those that may be linked at the individual research subject level.
- Applicants should clearly describe the plans for the study sample, data management, data analysis plans, project products, dissemination, and data archiving.
- Applicants should describe the potential impact of this study in terms of the stated purpose and goal of this solicitation.
- Applicants should identify the limitations of the proposed study and their approach to addressing anticipated challenges. This might include such considerations as generalizability of findings, recruitment and retention of the sample, data access concerns, missing data, or protection of human subjects.
- Applicants may choose to address as a part of their research design how the COVID-19 pandemic impacted delinquency and crime trajectories from a developmental and life-course perspective.
- Applicants should provide a detailed timeline for the proposed study.

New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose research on topics relevant to NIJ's Office of Research, Evaluation and Technology (ORET).
