## JUMP OUT BOYS CREED

- Each member for no reason shall ever fight with his brother
- Each member must respect and obey all rules of the Jump out Boys creed
- If you do not work G.E.T. or have never worked G.E.T., then you cannot become a member
- Anyone not working G.E.T. still has input and his opinions are valued for further revisions and consultation, but the current Jump out Boys working G.E.T. have the final say and are the only ones that can vote for new members
- Each new ~~prospect~~ <sup>POTENTIAL MEMBER</sup> must have the approval from all members in order to become a Jump out Boy. Two thumbs down and the decision goes to the (3) person committee
- The Black Book will, at all times, be kept offsite of any unauthorized location
- The Keeper of the Black Book is responsible for the book at all times
- Each new Jump out Boy shall be assigned a number in sequential order and branded the Jump out Boy
- The Jump out Boy must be worn on the outside right lower ankle area (exceptions apply)
- The template will be held by the tattoo artist, one member of the of the Jump out Boys and in the Book
- The Jump out Boys will be comprised of three board members. Any matters which cannot be agreed upon, will be decided by the board members. Each board member can be removed if the total number of people in the Jump out Boys agree to remove him. The board member can also choose at any time to leave the position of board member and elect a new board member of his choice

- At no time, can the newly assigned Jump out Boy, vouch or cast a vote at the time of their initiation.
- The Book will contain the Jump out Boys number, real name, date of initiation, date(s) of shooting(s), and date person started G.E.T.

## Jump out Boys Mission

The mission and origin of the Jump out Boys is to recruit real people whos work ethic is above all others anywhere. Jump out Boys are alpha dogs, who think and act like the wolf, but never become the wolf. They understand when the line needs to be crossed and crossed back. They need to work hard, they need to get guns, they need to take bad people to jail and sometimes they need to do the things they dont want to do, in order to get where they want to be. In conclusion, They need people like us, who gets there first and leaves last. Jump out Boys are not afraid to get their hands dirty without any disgrace, dishonor or hesitation. We are committed to each other, committed to our job and committed to excellence.

## The Initiation

The night of the initiation will be sponsored by the newly recruited Jump out Boy. The new Jump out Boy will be responsible for all costs unless offered by the members. The initiation will include the history of the Jump out Boys, it's purpose and the expectations of being a Jump out Boy. The new member will be informed of the Jump out Boy creed, given a number, and shown the Black Book.


