Agency-Specific Responses to Law Enforcement Employee Recording Devices Survey

Police agencies in Wisconsin were asked questions about their usage of recording devices in an optional portion of the 2020 Law Enforcement Employee Annual Survey that was sent out to Wisconsin Uniform Crime Reporting (UCR) registered agencies in November 2020. 436 agencies responded to the Annual Survey, and 434 of those agencies chose to respond with information about their use of dashboard and body-worn cameras. A select portion of their responses – pertaining to their possession of recording devices and the challenges they have associated with obtaining them – are included in this document.
