## e. At-Large Planning Commissioner Zoning Text Amendment

A Zoning Text Amendment is being proposed to the Placer County Code, Chapter 17, Article 17.60 pertaining to the two at-large Planning Commission Seats. The proposed Zoning Text Amendment will allow the two at-large Planning Commission members to reside part-time east of the Sierra Crest or west of the Sierra Crest while recognizing the unique nature of that region that the at-large Planning Commissioner represents.
