# Ending the HIV Epidemic - Primary Care HIV Prevention HRSA-23-025



## Up to \$50 million to expand HIV prevention, testing, and treatment services at health centers

#### WHAT IT DOES

Health centers will use fiscal year (FY) 2023 Ending the HIV Epidemic — Primary Care HIV Prevention (PCHP) funding to:

- Increase the number of patients counseled and tested for HIV.
- Increase the number of patients prescribed pre-exposure prophylaxis (PrEP).
- Increase the percentage of patients newly diagnosed with HIV who are linked to care and treatment within 30 days of diagnosis.

Health centers will focus on PrEP prescribing, outreach, HIV testing, and workforce development. Example activities include adding and training personnel who will deliver and support HIV prevention services; enhancing technology to support tele-PrEP; and purchasing and providing HIV home test kits that can be integrated with PrEP services. FY 2023 PCHP awards will build upon FY 2020, FY 2021, and FY 2022 PCHP investments to over 360 health centers by adding up to 140 health centers as new award recipients. The funding is part of HHS' Ending the HIV Epidemic in the U.S. (EHE) initiative, which aims to reduce the number of new HIV infections in the U.S. by 90 percent by 2030.

#### WHO DOES IT SERVE

Health centers serve people who are disproportionately affected by HIV, making them a key point of entry to HIV prevention, testing, and treatment services. This funding will support health center patients in targeted geographic locations

where there are a substantial amount of new HIV infections.

### **AWARD INFORMATION**

- Approximately \$50 million for up to 140 awards (\$350,000 per award)
- Three-year period of performance (September 1, 2023 – August 31, 2026)

#### WHO CAN APPLY

Health Center Program operational (H80) grant recipients that:

- Have at least one operational service delivery site (i.e., site that operates at a fixed address; intermittent and temporary sites do not qualify) in one of the <u>targeted</u> geographic locations.
- Have not received FY 2020, FY 2021, or FY 2022 PCHP awards.

#### **HOW TO APPLY**

FY 2023 PCHP applications include two required phases that are due in:

- 1. Grants.gov by January 17, 2023.
- 2. <u>HRSA Electronic Handbooks</u> by February 16, 2023.
