IHCP reminds providers of EVV dates and personal care services procedure codes that require EVV

As announced in *Indiana Health Coverage Programs* (*IHCP*) *Bulletins* <u>BT201750</u> and <u>BT201820</u>, federal law according to the 21st Century Cures Act directs states to require providers of personal care services and home health services to use an electronic visit verification (EVV) system to document services rendered. The implementation date for requiring use of an EVV system for personal care services is **January 1, 2021**. The implementation date for requiring use of an EVV system for home health services remains January 1, 2023.



The IHCP EVV solution

The IHCP is using the Sandata system as the State-sponsored solution for implementing federal EVV requirements, as announced in <u>BT201855</u>. The Sandata EVV system is <u>Health Insurance Portability and Accountability Act</u> (HIPAA)-compliant and incorporates verification of the federally mandated data elements. In partnership with DXC Technology, the <u>CoreMMIS</u> system has been configured to integrate with the Sandata EVV system.

Providers may choose to use an EVV solution other than Sandata. However, providers will be required to export data from their chosen system to Sandata's "Aggregator" for integration with *CoreMMIS*. This requirement will be necessary for documentation, billing, and reimbursement purposes. Sandata's Aggregator will capture data from Sandata EVV users and from other EVV solutions; providers using other solutions must work with Sandata to create an export interface with the Sandata Aggregator.

The Sandata EVV system includes both mobile visit verification (MVV) and telephonic visit verification (TVV) options and an administrative portal to manually manage employee and visit data. If providers require specialized employee management software to automate with a human resource system or other more advanced scheduling features, this specific solution may not meet those needs. In those instances, providers are encouraged to research other options with Sandata or with other companies.

Procedure codes for personal care services that require EVV

The procedure code and modifier combinations in <u>Table 1</u> for personal care services will require EVV for documenting the services rendered, beginning January 1, 2021.

This information will be reflected in the next regular update to the Service Codes That Require Electronic Visit Verification code table, available from the <u>Code Sets</u> page at in.gov/medicaid/providers.
