Dear colleagues,

At our next Committee meeting we are going to have a structured dialogue with Commissioner and will be discussing the key priorities of the Commission in research and innovation with a particular focus on challenges related to the EU vaccines strategy.

Europeans can call, message and use mobile data anywhere in the EU without extra costs thanks to the 'Roam like at home' policy. As the current regulation will soon expire we are looking forward to a presentation by Director Rita Wezenbeek (DG CONNECT) on a new proposal prolonging the current rules by 10 years and amending them where necessary.

Furthermore, Members will hear a presentation by <u>DG EPRS</u> and have an exchange of views with the Commission regarding the general conduct of impact assessments. According to the inter-institutional agreement on better law-making agreed in April 2016 the EU Parliament takes full account of the Commission's impact assessments when deciding on legislative proposals. Members consider this to be part of Parliament's scrutiny of the Commission.

Finally, we will be adopting our reports on the Strategy for Energy System Integration, the Strategy for Hydrogen, the draft opinion on Shaping the digital future of Europe and Amending Decision 2008/376

Establishing the European High Performance Computing Joint Undertaking

The ITRE Committee will have a first exchange of views with the rapporteur Ms Maria da Graça Carvalho (EPP) who will present her draft report concerning the proposal for a Council regulation establishing the European High Performance



Computing Joint Undertaking. The EuroHPC Joint Undertaking was established through a Council Regulation in October 2018 to coordinate supercomputing strategies and investments. It is a partnership co-funded by the EU, the participating States and the private sector. The proposed Regulation is a continuation of the existing initiative, introducing modifications to adapt the current Regulation to the next MFF. It will use funding from the new MFF programmes from 2021-2027 (Horizon Europe, Digital Europe and CEF programmes).



A reinforced role for the European Medicines Agency in crisis preparedness and management for medicinal products and medical devices

The ITRE Committee will hear Ms Mélin, the rapporteur, on 18 March who will present her draft opinion on a reinforced role for the European Medicines Agency. The draft opinion contains

extensive amendment to the Commission's proposal, including as to the functioning of the proposed new Medicines and Medical Devices Steering Groups. It specifies that the regulation apples to both human and veterinary medicinal products and medical devices. The draft opinion also clarifies the importance of compliance with data protection law.

Structured dialogue with Ms Mariya Gabriel, Commissioner for Innovation, Research, Culture, Education and Youth

The ITRE Committee will hold a structured dialogue with Ms Mariya Gabriel, Commissioner for Innovation, Research, Culture, Education and Youth. The structured dialogue can be expected to focus, in particular, on research issues related to the EU vaccines strategy. In addition, with the start of the new framework Programme Horizon Europe and the recent



publication of two legislative proposals establishing institutionalised partnerships, the dialogue will be a good opportunity to discuss more broadly the key priorities of the Commission in research and innovation.



European data governance (Data Governance Act)

ITRE will hold a first exchange of views on the Commission proposal on the "Data Governance Act". The Commission's proposal is the first of a set of measures announced in the February 2020 European strategy for data. Its aim is to foster the availability of data for use by increasing trust in data intermediaries and by strengthening data sharing mechanisms

across the EU. In that respect it will inter alia: i) address the reuse of certain categories of protected public sector data that is conditional on the respect of the rights of others; ii) create a notification regime for data sharing providers in order to increase trust in sharing personal and non-personal data and lower transaction costs linked to B2B and C2B data sharing; and iii) facilitate data reusability on altruistic grounds. The proposal also provides for the creation of a European Data Innovation Board.

Presentation of DG EPRS findings and exchange of views with the Commission regarding Commission's conduct of impact assessments – methodology and practical experience

Parliament attaches particular importance to the impact assessments carried out by the European Commission. ITRE Members are interested in gaining deeper understanding of the challenges in practice faced by the Commission in developing



the assessments. This includes, among other aspects, the challenges encountered in different policy areas and the means via which those are tackled. Members consider this to be part of Parliament's scrutiny of the Commission.
