# REMINDERS: 70th Conference on Exceptional Children

The **70th Conference on Exceptional Children** will be held at the Koury Convention Center, 3121 West Gate City Blvd., in Greensboro. The Pre-conference Institutes will be held on Wednesday, November 17th from 9:00 am - 4:00 pm. The General Conference will run Thursday, November 18th, from 8:15 am - 4:30 pm and Friday, November 19th from 8:30 am - 12:15 pm. - REMINDER: Due to COVID-19 protocol, we will not be able to accept any registrations after 5:00 pm on November 1, 2021. There will be no on-site registrations or substitutions for this conference.

### **Conference Information**

This year we will use colored wristbands rather than name tags to identify conference participants. These will be required to enter all sessions and receive meals.

- Participants who uploaded proof of full vaccination will receive their bands in the mail at the address entered on the registration.
- If you have not received your wristband by November 12<sup>th</sup> contact <u>Kelly.Breest@dpi.nc.gov</u>. We will arrange for you to pick up your band at the Conference.
- Participants who are not fully vaccinated will need to bring a negative COVID-19 test (taken within 72-hours) to pick up their wristband at the Conference, Desk 4. This must be picked up before you will be allowed to enter any sessions.
- Following guidance from NCDHHS, either a polymerase chain reaction (PCR) or a rapid Antigen test will be accepted to meet the requirement of a negative COVID-19 test taken within 72 hours prior to the first event attended. No other data, including Antibody tests, will be accepted.
- The wristbands will be required to be worn for the full length of the conference and will not be replaced daily.
- While inside the Koury Center/Sheraton Hotel, masks will be required of all attendees no matter the vaccination status. This is a hotel requirement.

## **Conference Materials**

All session materials will be stored on the Conference App.

- Once the App goes live, all registered participants will receive instructions on how to download the App to a mobile device.
- There will also be a web App that is accessible to all registered participants as long as you have internet or data access.

- During the conference, internet access will be provided to all registered participants for one device.
- The App will allow participants to create their own schedule of preferred session. This
  is not a registration for a particular session and <u>does not</u> guarantee you a seat. Session
  seating is on a first-come first-serve basis until seat capacity is reached.

### **Federal Reporting**

#### 2020-2021 End of Year Data Submission for Indicator 11

All Public-School Units are responsible for certifying Indicator 11 - Child Find in ECATS. The Indicator 11 count captures the percent of students for whom a referral was received, and placement determined within 90 days and is based on data from July 1, 2020 through June 30, 2021. The Indicator 11 Count opened October 1, 2021 and is due by close of business October 29, 2021. The training video, ECATS Webinar – Indicator 11 Reporting, along with additional reference handouts are posted in each district's ECATS instance on the main page under Resources > Federal Reporting. Please submit any questions or student level data corrections directly to ZenDesk to ensure that problems with data are corrected efficiently.

#### 2020-2021 End of Year Data Submission for Indicator 12

Indicator 12 captures data on students who received Part C services and were referred to Part B during the July 1, 2020 through June 30, 2021 fiscal year. All students must have an IEP developed within 90 days of the referral and receive services by their 3rd birthday. Indicator 12 will be submitted on spreadsheets by all PSUs and can be accessed by clicking this link: <a href="Indicator 12 Spreadsheet">Indicator 12 Spreadsheet</a> or by going to the ECATS site under Resources (<a href="https://www.dpi.nc.gov/districts-schools/classroom-resources/exceptional-children/every-child-accountability-tracking-system-ecats/resources">https://www.dpi.nc.gov/districts-schools/classroom-resources/exceptional-children/every-child-accountability-tracking-system-ecats/resources</a>). The spreadsheet has a tab with helpful clarifications to assist PSUs on entering their data and can be submitted at any time prior to the due date of October 29, 2021. Charter Schools do not need to submit an Indicator 12 spreadsheet this year. Please email all Indicator 12 spreadsheets to ecindicators@dpi.nc.gov.

#### Important Federal Reporting Reminder: Submission Timeliness

If your district does not certify the data required for Indicators by the due date, your data may be certified by state staff. The integrity of the data is always at risk when the Department of Public Instruction must finalize the data for your district.

#### **Grant Information**

#### • IMPORTANT: IDEA Grant Deadline

All IDEA Initial Grant applications still pending must have the corrections submitted and the initial grant approved by November 30, 2021. Fiscal Monitors will communicate with the EC Directors the specific areas needing attention to complete the IDEA grant submissions. Upon receiving approval of the initial grant application, PSUs will have fourteen days to submit the 2020-2021 MOE. Newly opened charter schools will receive training for IDEA grant application in December and notification of IDEA grant deadline during the training.

#### • Maintenance of Effort (MOE) Training & Technical Assistance

If you were unable to attend the MOE training or if you need a refresher, the recording, along with the PowerPoint, are available on the Exceptional Children website <a href="here">here</a> and on the NC CCIP Home Page. The MOE Expenditure Table opened for PSUs with approved IDEA grant on October 1, 2021 and is due on October 31, 2021.

#### Special Grants

Grant applications opened on September 7, 2021. Special grants, with the status of Chief Administrator Approved, are reviewed monthly after the 15th. Notification of review is made through NC CCIP. For your review, the Special Grants Training recording, along with the PowerPoint are available on the EC Website <a href="here">here</a> under the Special Grants section.

Please ensure that budget and grant use of funds align to ensure timely approvals.

### • IDEA/ American Rescue Plan Act of 2021 (ARP)

The American Rescue Plan funds have been allotted under the following Program Report Codes. The budgets will be submitted the same way as the IDEA budgets. A new application is not required.

### PRC 185 IDEA/American Rescue Plan Act of 2021 (ARP) Basic – 611

The funds will align with the IDEA Section 611 Use of Funds. If the funds are budgeted for items not currently in the Section 611 Use of Funds, the Use of Funds must be revised.

#### PRC 186 IDEA/American Rescue Plan Act of 2021 (ARP) Preschool – 619

The funds will align with the IDEA Section 619 Use of Funds. If the funds are budgeted for items not currently in the Section 619 Use of Funds, the Use of Funds must be revised.

### PRC 187 IDEA/American Rescue Plan Act of 2021 (ARP) CEIS

For PSUs with mandatory CEIS, the funds will align with the CEIS Use of Funds. If the funds are budgeted for items not currently in the CEIS Use of Funds, the Use of Funds must be revised.

For PSUs with an approved IDEA grant and needing a grant revision, it should be submitted at the same time as your MOE Expenditures. Contact your fiscal monitor for additional information regarding the IDEA grant status and the submission of the budgets.

- Allotments can be seen on the allotment page of the IDEA Grant in CCIP
- Budgets are submitted through each PSU's budgeting system and will be pulled into CCIP
  o Directors/Coordinators can view the budgets once submitted by clicking on the budget link
  on the IDEA Grant Sections page
  - o The funds can be utilized on any IDEA allowable expense. The Chart of Accounts now contains the allowable budget codes for PRC 185, 186 & 187. It can be found here:

- If the budget aligns with the current Section 611/619 and or CEIS Use of Funds, the IDEA Grant does not need to be revised.

- If the budget includes line items not currently in the Section 611/619 or CEIS Use of Funds, the IDEA Grant must be revised to include the new line items. Designate in the Use of Funds that the revision items are for PRC 185/186/187.
  - o Example: Current Use of Funds does not include funds for professional development. Add to the Use of Funds:
    - § Revision for PRC 185: Professional Development Workshop Expenses
- After the IDEA Grant and all related budgets are approved, SPD notifies NCDPI School Business.
   SPD does not allot the funds or know when the funds will be allotted.

## NC SIP Updated Instructor Process for Foundations of Math (FoM) and Reading Research to Classroom Practice (RRtCP)

### Blindness Awareness Month – Information and Fun Facts

You may have heard audible tones or seen tactile push buttons at intersections around your town or city. These are called Accessible Pedestrian Signals. Accessible Pedestrian Signals (APS) are integrated devices that communicate information about the WALK and DON'T WALK intervals at signalized intersections in non-visual formats (i.e., audible tones) to pedestrians who are blind or have low vision.
