2019-20 Students with Disabilities Exit Count - Due 10/7/2020

The Exit Count report is now available to all LEAs, Charter Schools and State Operated Programs on ECATS production under **Reports>Standard Reports> Special Education**. Due to the timing of the release of the reports and the training materials, the EC Division has extended the due date for all districts to be certified no later than October 7, 2020. The Exit data are based on the July 1, 2019 through June 30, 2020 fiscal year.

The attached <u>training video</u> will explain the process for running the report, correcting errors and certification. The tip sheets referenced in the video are posted in each district's ECATS instance on the main page under Resources – labeled "ECATS Training Webinar Videos – Last Updated 9/14/20". Tip Sheet: Eligibility Worksheet - Specific Learning Disabilities (new policy)

The SLD worksheet currently in ECATS will remain the same. Tip Sheet: Related Service Support Descriptions (RSSD)

The EC Division has received questions regarding how to document supplemental aids and supports that were previously included on a separate stand-alone form, RSSD, prior to the implementation of ECATS and the new EC forms. While this information was previously provided at the May 2017 Regional Director's Meeting, it is appropriate to update the information and re-release in a Tip Sheet. This information is being finalized and will be ready for release on or before Wednesday, September 23, 2020.

If released prior to next week's EC Division Weekly Update, it will be posted to the <u>ECATS website</u> and/or included in the next Monday Message with a reminder of its delivery in the following in the weekly update.

Monitoring: Non-Public Schools and Community Residential Centers

The Policy, Monitoring and Audit section is developing a memo to identify non-public schools with EC Program Approvals. This list is maintained by the EC Division to assist LEAs in the placement of children who require FAPE through services in private schools or facilities. Over time, the number of options on this list has decreased. Therefore, within this memo, technical assistance resources will be highlighted in order to support LEAs when considering options that may not be included on the list maintained by the Division.

Additionally, there will be some changes in how the EC Division will be monitoring Community Residential Centers. Those details will be included in this memo and is expected to be issued in next week's EC Division Weekly Updates.



PRC 132 COVID Funding Reporting

Superintendents and CFO's should have received a spreadsheet which lists all COVID-19 funding to date, with the request for each PSU to report on all funds received monthly, as required by Office of State Budget Management (OSBM). Specifically, for EC reporting is needed for all PRC 132 funds. The initial reporting is due September 20 and should reflect the *number of students* served and the *types of services* (ESY, Additional Services, Comp Ed) provided through August 30, 2020. Please complete this report with the following convention (#, ESY; #, Additional; #, Compensatory Ed). An example is included below.



Subsequent reports will be due on the 20th of each month, reflecting data from the previous month. Questions regarding this should be directed to Sherry Thomas or Matt Hoskins.

ECATS Paperclip: Contingency Plans

There have been questions regarding paperclipping Contingency Plans to students' ECATS electronic file and requests for additional data storage. As a reminder, this is not a requirement established by the EC Division and is optional at the local level. If LEAs are receiving notifications that its data limits have been reached,

please review the information below to determine if internal data management procedures should be reviewed.

ECATS Paperclip Storage

With the ECATS contract, there is enough data storage for LEAs to be able to upload approximately 5-6 pages per total ADM (general education students + EC students). In addition, there are some minimums and maximums in place. The minimum allotment an LEA received is 100 MB; the most an LEA can receive is 23,000 MB (or 23GB).

- 100 MB is a little over 3000 pages per school year.
- 23,000 MB is a little under 700,000 pages per school year

This data allocation is renewed annually. While only a rough estimate, LEAs could develop a usage guide by estimating how the document allocation for general education students can be repurposed to increase the number of documents available per EC student.

As a reminder:

Data is allocated by LEA; not by user or by student.
 (Therefore, a few users could potentially use the entire LEA's annual allotment.)

The following items should be attached to the electronic student record via PaperClip:

- The initial consent for Evaluation (Parent Consent to Evaluate)
- The initial consent for Placement (Parent Consent for Services)
- Parent consent to access Public Insurance. *

*Users should begin this process with any initial referral or initial request to access private insurance that occurred beginning July 1, 2019, and forward. For documents prior to this time, the student's EC file is the authoritative source.

Currently, there isn't a document requirement in place for general education students.

Supporting SWD When A Face Covering is Required

Since the beginning of the pandemic, Exceptional Children Division Consultants have been repeatedly contacted by parents and school staff with concerns regarding communication access for students with disabilities when face coverings are required and worn by communication partners. This document provides information about the potential impact face coverings may have on communication for students with disabilities as well as examples of reasonable accommodations to consider if students experience communication challenges due to face coverings.
