Big data technologies and Artificial Intelligence

On 23 February Policy Department on Budgetary Affairs organized a workshop on the use of big data and Artificial Intelligence in fighting corruption and misuse of public funds. The workshop aimed to investigate how the new technologies are already being used in the field of fraud, corruption and malpractice detection, as well as prevention, what are the Al's limitations, and how its use could be improved.

The impact of COVID-19 crisis on EU security and defence

COVID-19 has also impacted EU security and defence issues. This paper explores how, and presents the lessons to be learnt and recommendations for the future. This analysis for SEDE committee shows the challenges of the pandemic on security and defence - how the pandemic reveals vulnerabilities, while multiplying and accelerating trends and threats. It looks at which lessons the EU should learn in order to better manage and prepare for such crises, and makes strategic recommendations.



Air pollution and COVID-19

COVID-19 is spread through person-to-person contact but the incidence and severity of the disease are potentially influenced by many factors, including air pollution. The study requested by ENVI committee discusses the potential effects of air pollution on COVID-19, given what is known about health effects of air pollution in general. It concludes that current studies on correlations between air pollution and the spread of COVID-19 are not robust enough to establish a causal connection.



Cultural and creative sectors in post-COVID-19 Europe

Policy makers in Europe have taken considerable and unprecedented measures to support the Cultural and Creative Sectors during the COVID-19 related crisis. Pre-COVID-19, the Cultural and Creative Sectors (CCS) were already characterised by fragile organisational structures and working practices. Since the COVID-19 pandemic hit Europe in spring 2020, the CCS have been among the most negatively affected sectors.
