Guidelines for the 2022 Budget - Section III

The guidelines are the first resolution that the Parliament adopts in a budgetary procedure. It is aimed at laying down Parliament's expectations for the budget of the following year. The resolution will be adopted in plenary in March and shall give guidance to the European Commission before adopting the Draft Budget. 2022 will be a year of social and economic recovery for Europe and providing sufficient funding will be critical for accomplishing the twin

transition towards climate-neutrality and digital leadership and in shaping Europe's Digital Decade.

The draft opinion will be presented in the ITRE Committee on 28 January, while the deadline for tabling amendments is 2 February 2021, at 12.00.
