Terms of Service:

A minimum 3-year term beginning September 1, 2024, through August 31st of 2027. Directors may serve no more than a total of six (6) consecutive years, which shall be comprised of a combination of two (2) three (3) year terms. Upon completion of a total of six (6) years, Directors shall be required to resign from the Board and shall not be eligible for re-election to the Board until one (1) year has elapsed.

Position Description:

- Has solid ethics, a strong community involvement and belief in the purpose of the South Metro Denver Chamber
- Attendance at monthly board meetings (currently held the fourth Thursday of each month from 7:30 am 9:00 am)
- Has demonstrated the ability to serve through committee service or other community involvement
- Has time to commit to the Chamber, its activities, various Chamber events and its Board
 of Directors as needed attendance at two or more Chamber events per month.
- Understands the board members may not act where there is real or perceived conflict of interest
- Are willing to serve a minimum of 3 years

- Activity and involvement with South Metro Denver Chamber
- Current member of South Metro Denver Chamber, in good standing
