Subject: 2020 Quarter 2 CCO Financial Update – COVID Impact

COVID Impact on CCO Cash Flow

The Oregon Health Authority (OHA) has partnered with Coordinated Care Organizations (CCO) throughout 2020 to support providers and the community during this public health emergency. As part of the COVID response, OHA increased the cash flow to CCOs by paying out the 2019 and 2020 quality pool funds early during calendar year 2020. As a condition of this early release, OHA required CCOs to report how they were distributing funds to their network and posted that information to a website. OHA also tightened the Medical Loss Ratio requirement for 2020¹ to ensure this cash flow was distributed to the providers and community. Ensuring access to high quality providers is critical to the Oregon Health Plan and continues to be a high priority as this emergency persists.

Much of this funding was used to support providers when elective procedures were held by the Governor and personal protective equipment (PPE) was in short supply. A noticeable decline in utilization occurred in Quarter 2 (Q2) of this year. That decline is reflected in an approximate 25% decrease in total paid (i.e. fee-for-service) amounts reported to MMIS in April. By June, the decline in total paid amounts was back within 10% of a recent pre-COVID average. Declines in utilization varied widely by service category, ranging from none for pharmaceutical drugs, to over 80% for non-emergent medical transportation. Please see additional comments in the Q2 summary bullet points below.

The following provides a view into the CCO financial results from Q2 2020.

2020 Q2 Summary and Key Indicators

The Oregon Health Authority (OHA) monitors the financial condition of the Coordinated Care Organizations (CCO) on a quarterly and annual basis. CCOs submit their financials 60 days after the end of the quarter. The financials are posted to the website and reviewed by OHA's internal team.

The first view into the COVID impact on each CCO's financials was their Q2 submissions. OHA uses the quarterly financials to ensure compliance to solvency standards and reviews high-level figures to understand performance; however, the quarterly submission must be evaluated understanding seasonality in the Medicaid program (e.g. Quality Pool funding, etc.) and different accounting treatments for accruals

¹ In CY2020, CCOs are required to hold a Medical Loss Ratio (MLR) of 85% or more. If below 85%, CCOs will required to rebate money back to OHA. Typically, the 85% MLR is evaluated using a three-year rolling average.

by business model. Specifically, the 2020 early experience is impacted by the two new CCOs (PacificSource Lane and Marion Polk) coming into the market. Generally, OHA relies on the audited annual submission for a final performance review for the CCO program.


For the 2020 Q2, generally the following was true:

- The CCO program year-to-date statewide operating margin is 0.6%.
- The CCO program went from an approximate \$10.8 million dollar loss and -1.0 operating margin in Q1 2020 statewide², to a \$9.7 million dollar profit and +2.2% operating margin in Q2 2020.
- The CCO program saw a decline in utilization during Q2 as noted in the introduction section. The decline can be observed in changes to per-member service expense from Q1 to Q2, which ranged from -26.3% (Allcare CCO) to +4.0% (Advanced Health). This range excludes the two new CCOs (PacificSource Lane and Marion Polk) and Trillium Community Health Plan due to membership fluctuations. See next section for individual CCO breakdown.
- Due to emergency federal legislation, membership increased approximately 7% in Q2, as members were no longer allowed to be disenrolled from OHP in most circumstances.

Financial Comparisons & Results

The following are financial comparisons that provide more detail and context to the Q2 results.

Statewide CCO Operating Margin: The year-to-date CCO Statewide Financial Result shows a 0.6% operating margin, which indicates a lower year-to-date profitability level for CCOs this year compared to their prior years' financial performance.



² The CCO program would be in a profitable position in Q1 if Trillium Community Health Plan (Lane) experience is excluded. Trillium incurred a \$10.1 million Health Insurance Fee charge that will later be reimbursed, and separately saw a significant decrease in membership.

Member Services and Administrative Costs Breakdown: A breakdown of the key financial ratios by quarter shows a drop of member services spending in Q2 compared to Q1, which resulted in an improved operating margin. Per the analysis into PMPM member service by category, it is assumed the decrease of member service percent in Q2 is linked to the decreased medical service utilization due to COVID-19.

The largest drop was noted in the "Hospital Services" category (-31%) and followed by the "transportation" category (-26%). While a spending drop could be seen in most of the member service categories, increases were still noted in three service categories:

- "Other Member Service Expenses" shows a significant increase of 1,918% (Q2 versus Q1). This could be explained by CCOs' discretionary spending linked to early Quality Pool payment. Most CCOs made significant Quality Pool payments to their providers in Q2, while such spending was none or minimal in Q1.
- "Substance Abuse Disorder" spending shows a significant increase of 44% and "Mental Health" spending shows an increase of 7% in Q2 versus Q1. This increase trend is consistent with the findings of elevated levels

of adverse mental health and substance abuse during COVID-19 which was noted in one of CDC's report/surveys. (https://www.cdc.gov/mmwr/volumes/69/wr/mm6932a1.htm)

Member Service Expense Change by CCO: Most CCOs see a drop of adjusted PMPM Member Service Expense in Q2 compared to Q1. However, there are still a few of CCOs show increases.

Continued Evaluation

Based on the review of 2020 Q2, OHA's early release of the quality pool funds and the available revenue due to the dip in medical utilization was shared with providers and the community across the CCOs. While there was a statewide reduction in per-member, per-month medical service spending; the substance abuse and mental health spending stayed the same or increased from Q1 to Q2. Generally, CCOs are in a positive position after the Q2 submission, but are not holding on to a significant amount of profit.

OHA will continue to monitor the CCO's financials as there is significant room for change as OHA receives Q3 and Q4 submissions that are due November 30, 2020, and April 30, 2021 respectively.

Background

COVID-19 Weekly Report data will be finalized every Sunday at 11 p.m. PDT, and the report will be published on Wednesday. Please note that the data reported here are continually being updated. For daily up-to-date information, visit the OHA COVID-19 web page: https://govstatus.egov.com/OR-OHA-COVID-19.

As of 11 p.m. Sunday, October 26, there have been 42,436 cases of COVID-19 reported to the Oregon Health Authority. Of these, 2,156 (5.1%) are "presumptive" cases—i.e., people with COVID-19-like symptoms and close contact with a confirmed case, but who did not have a confirmatory laboratory test. Though not confirmed, presumptive cases are highly likely to have COVID-19, given their specific symptoms and known exposure. Presumptive cases are encouraged to seek testing to confirm that they do have COVID-19. Presumptive cases who test positive are recategorized as confirmed cases.

These data represent a snapshot of COVID-19 risk factors and clinical and demographic characteristics of cases, and they include data on cases with pending investigations. Not all cases have been interviewed at the time of this report. The data shown in this report come from Oregon's electronic disease surveillance system for reportable diseases.

During the week of October 18–October 24,* 31,448 Oregonians were tested for COVID-19, and 6.5% of them had a positive result.† Not all positive tests represent new cases; some are from specimens collected from people who had already been counted as presumptive cases. The number includes tests done at all locations, including commercial non-hospital-based laboratories, hospital laboratories and Oregon State Public Health Laboratory.

The original version of this document posted on October 28 included errors in the Weekly Summary, the Child Care Facilities reporting active outbreaks table, the HOSCAP tables, and the total number of cases associated with congregate living settings.

Weekly Report Summary

During Monday, October 19, through Sunday, October 25, OHA recorded 2,642 new cases of COVID-19 infection—up 14% from last week's tally of 2,327 and the highest weekly tally recorded in Oregon to date. The number of Oregonians newly tested rose another 8.6%, to 31,448; the percentage of tests that were positive held steady at 6.5%. Twenty-seven Oregonians were reported to have died in association with COVID-19—compared to 28 last

week. One hundred forty-four Oregonians were hospitalized. The 42,436 COVID-19 cases reported in Oregon to date computes to 1,002 cases per 100,000 Oregonians, or just over 1% of the population. Of these, 655—1.5% of all cases reported to date—have died in association with COVID-19, giving a mortality rate of 15.5 deaths per 100,000 Oregonians. Recent data on mortality in Oregon, including deaths related to COVID-19, are available at https://public.tableau.com/profile/oha.center.for.health.statistics.

The incidence of reported infection has been highest in persons 20–49 years of age, who account for 39% of Oregon's population and 56% of reported cases. Persons <30 years of age make up 37% of Oregon's population and have accounted for 37% of reported cases but only 9% of hospitalizations and 0.3% of deaths. Hospitalization and death rates increase with age. Although only 3.6% of Oregonians are 80 years of age or older, they account for 332 (51%) of COVID-19-associated deaths; 490 (75%) of the deaths are among Oregonians 70 years of age or older. Clinical Characteristics, Risk Factors and Demographic Characteristics


Figure 1 shows the number of cases reported by week of onset and epidemiologic link. Figure 2 shows the number of sporadic cases reported by week of onset and race. Figure 3 shows the number of sporadic cases reported by week of onset and ethnicity. Figure 4 provides information on signs and symptoms from all COVID-19 cases. Of 42,436 cases, 32,300 (76.1%) reported having signs and symptoms of COVID-19. The most commonly reported symptoms are cough (n=21,549, 50.8%) and headache (n=20,618, 48.6%). Figure 3 provides information on the percentage of COVID-19 cases that report symptoms. Figure 4 provides information on risk factors from all COVID-19 cases. The most common risk factors are having contact with a known COVID-19 case prior to symptom onset (n=28,604 67.4%) and having underlying medical conditions (n=18,983, 44.7%). Note that a person may report more than one sign/symptom or risk factor.





Epidemiologic link designations


Sporadic: Cases who do not have known exposure to another case or outbreak. Outbreak: Cases who have a shared, defined exposure with at least one other case. For example, a defined exposure could be an event, a workplace, a congregate facility, etc. Cluster: Cases who had contact with another case, but the exposure is not well defined. For example, cases from two households who interacted many times prior to illness onset. Household: Cases who were exposed to another case in their household. Close contact: Cases who were exposed to another case, not in their household. This designation was added on 7/15.


Due to the lag between case reporting and case investigation, the proportion of cases categorized as sporadic is high in the most recent week or more; some of these cases will be recategorized after investigation is completed.















Recovery


OHA staff periodically call people with reported COVID-19 who experienced fever, cough, shortness of breath or diarrhea and were initially interviewed before May 1, when OHA changed its definition of recovery, to inquire about resolution of symptoms. This group includes 1,884 people who were all diagnosed before mid-April and have not succumbed to their illness. Among these, 1,682 (88.8%) are considered to have recovered, and a recovery date is available for 1,387 people; their time to recovery is depicted in Figure 15. Of these 1,884 people, 16 (0.8%), have not yet recovered; and recovery status is not available for 186 (9.8%). People are assumed to have recovered three days after resolution of all symptoms. The median time to recovery among non-hospitalized symptomatic cases is 20 days (interquartile range: 15–29 days); among symptomatic cases who were hospitalized it is 26 days (interquartile range: 18–37 days).

Weekly Care Facility, Senior Living Communities and Congregate Living Settings Report

OHA is publishing data on cases and deaths in care facilities, senior living communities, and congregate living settings that have three or more confirmed COVID-19 cases or one or more deaths (Table 5). Facilities with outbreaks that are considered resolved are moved to the closed outbreak list (Table 6). An outbreak is considered resolved if no new cases are identified for 28 days after the last case onset. Facilities will be removed from the closed outbreak list after 56 days. This list does not include correctional facilities.

In addition to the facilities listed, OHA is aware of 65 congregate settings of five or fewer beds that have three or more confirmed COVID-19 cases or one or more deaths. Because foster homes typically have relatively few residents, OHA follows the Oregon Department of Human Services practice in not naming these locations to protect patient privacy.

To date, there has been one death of a staff person who worked in a congregate care setting from COVID-19. To protect patient privacy, OHA does not report employee deaths by workplace or other potentially identifying information. Similar information will be released in the future in weekly reports only if OHA determines that such information, in addition to other information it releases, and information released by other agencies, like the Centers for Medicaid and Medicare Services, cannot be used to identify an individual. To date, there have been 3,710 cases and 385 deaths associated with congregate care settings.

Weekly Workplace Outbreak Report

OHA is publishing data on cases in workplace outbreaks. Given a cluster of cases in space and time, within plausible incubation periods for the pathogen, OHA epidemiologists will consider cases to be related—i.e., part of a workplace outbreak—unless a more likely alternative source for acquisition is identified. Any suspected workplace outbreak is required to be reported to the local public health authority (see OAR 333-018-015). Local health department and tribal partners investigate to identify workplace outbreaks. This list of outbreaks will be updated as investigations continue, and we learn about epidemiologic links between cases. This list may not reflect all the workplace outbreaks in Oregon.

To protect privacy, OHA is only reporting workplace outbreaks with five or more cases and only for workplaces with at least 30 workers. If more than 50% of the workers are COVID-19 cases, specific case numbers will not be reported. Case counts include all persons linked to the outbreak, which may include household members and other close contacts. The list below includes active workplace outbreaks (Table 7), meaning that there has been a case within the past 28 days. Outbreaks that are resolved are moved to a separate table of resolved outbreaks (Table 8). Outbreaks are removed from the closed outbreak list after 56 days.

The presence of correctional facilities and food packing and agricultural worksites on this list highlights the challenges of controlling COVID-19 in settings where people must work or live in proximity. People of color are overrepresented in agricultural and correctional settings, contributing to the higher rates of COVID-19 observed in these groups. OHA publishes these data in response to public request, but with some concern that workers or staff members at these workplaces might be subject to discrimination.

State and local public health officials work intensively with staff at workplaces where outbreaks are identified to isolate sick workers, test and quarantine those who have been exposed and implement workplace changes to reduce risk of transmission. Unless otherwise noted, public health officials have determined that these workplaces, their workers and their products do not pose significant risk to the public. Workers of a business with a workplace outbreak should never be subjected to discrimination or excluded from patronizing other

businesses. In fact, discriminating against workers or avoiding products might jeopardize the economic viability of essential local businesses.

Employers can support their workers with policies that ensure that ill workers are not in the workplace and are not penalized for taking sick leave. Employers should ensure that workers are aware of and understand these policies.

There have been 35 deaths and 8,172 cases associated with all workplace outbreaks that have been reported to date. To protect patient privacy, OHA does not report employee deaths by workplace. Cases that are associated with more than one workplace outbreak will be reported in the case count for all relevant workplace outbreaks.

Weekly Child Care Outbreak Report

OHA is publishing data on cases in child care settings. Given a cluster of cases in space and time, within plausible incubation periods for the pathogen, OHA epidemiologists will consider cases to be related—i.e., part of a child care outbreak—unless a more likely alternative source for acquisition is identified. Any suspected child care outbreak is required to be reported to the local public health authority (see OAR 333-018-015). Local health department and tribal partners investigate to identify outbreaks in these settings. This list of outbreaks will

be updated as investigations continue, and as we learn about epidemiologic links between cases. This list may not reflect all of the outbreaks in child care settings in Oregon.

As of September 23, 2020, OHA will report child care outbreaks with 2 or more cases in child care settings with the capacity for more than 16 students. Previously, OHA reported child care outbreaks with five or more cases and in settings with at least 30 students. Case counts include all persons linked to the outbreak, which may include household members or other close contacts. The list below includes active child care outbreaks (Table 9), meaning that there has been a case within the past 28 days. Outbreaks that are resolved will be moved to a separate table (Table 10) of resolved outbreaks. Outbreaks will be removed from the list of resolved outbreaks after 56 days. In addition to the 12 outbreaks listed below, there is one outbreak in a day care center that has a capacity of 16 or fewer children.

Weekly COVID-19 and Kindergarten-12th Grade School Report

OHA is publishing data on COVID-19 cases associated with schools that offer in-person instruction. This is to inform the public of potential COVID-19 exposure and to provide transparency surrounding COVID-19 in schools. School is defined as any place of learning for students from kindergarten through twelfth grade, or a subset, with at least 30 students enrolled. This includes, but is not limited to, public schools, private schools, parochial and charter schools. Staff is defined as any person who works full time or part-time at the school, regardless of their position. A volunteer is defined as any person who volunteers onsite.

Table 11 below includes all schools that have 1 or more cases of COVID-19 in students or staff/volunteers where the most recent onset occurred within the past 28 days. Schools that have 1 or more cases of COVID-19 in students or staff/volunteers where the most recent onset occurred more than 28 days ago will be moved to a separate table. Archived schools with COVID-19 cases, defined as a school with no new cases for 56 days after the last case's onset, will be removed from the COVID-19 Weekly Report.
