SIGNIFICANT INCIDENTS		
DATE	INCIDENT TYPE	SUMMARY
08/31/2023	Unsafe Operation	At about 1645 hours, rangers were flagged down for a report of a reckless driver. Rangers located the driver, a 34-year-old male resident of Grand Canyon, at his residence. Following investigation, rangers issued the subject a mandatory appearance violation for Unsafe Operation of a Motor Vehicle.
09/03/2023	Disorderly Conduct	At approximately 1615 hours, Coconino County Sheriff's Office (CCSO) requested rangers respond to Tusayan, AZ for a domestic in progress with children crying. Upon arrival, rangers learned that a family had clogged a toilet and gotten into a verbal argument. The incident was cleared as unfounded.
09/03/2023	Public Intoxication	Around 1930 hours, rangers responded to Desert View for a report of intoxicated individuals fighting. Following investigation, rangers separated the two parties, a 48-year old male and a 70-year-old male, both residents of Grand Canyon, for the evening and issued them warnings for Disorderly Conduct.
09/04/2023	Unsafe Operation	At around 1000 hours, rangers received a report of motorcycles operating unsafely in Grand Canyon Village. This is the second week rangers have received this report. Rangers were unable to locate the vehicles, but the investigation is ongoing.
09/04/2023	Domestic Violence	At about 2245 hours, rangers responded to Bourbon Street for a report of a cold domestic incident. Upon arrival, the female victim told rangers that she had been assaulted by her boyfriend, a 46-year-old male resident of Grand Canyon. The victim received medical attention; the investigation is ongoing.
09/04/2023	Weapons Violation, Disorderly Conduct	While taking a report for the above assault, at about 2330 hours, rangers received an anonymous report that a gun was being waved around at a party at on Bourbon Street. Rangers responded immediately, and upon investigation, found that no gun was at the residence. Rangers have opened a case and are investigating the false report.
09/06/2023	Arrest – DUI Drugs	At approximately 1145 hours, rangers initiated a traffic stop on a driver at Grand Canyon Visitor Center parking area. The driver, a 36-year-old male from Selma, OR, admitted to smoking marijuana. Rangers arrested the driver for Driving Under the Influence of Drugs and Possession of a Controlled Substance.
09/07/2023	Arrest – DUI	Around 2000 hours, rangers stopped a vehicle for driving behavior near Center Road on Highway 64. Following investigation, rangers arrested the driver, a 44-year-old male from Santa Barbara, CA for Driving Under the Influence of Alcohol.
09/09/2023	Domestic Violence	At about 2245 hours, rangers were requested by CCSO to Tusayan, AZ for a report of a domestic assault. On arrival, rangers located two female victims standing outside their residence. Ranger ensured the suspect remained inside the residence and separated from the victims until CCSO's arrival. CCSO took lead upon arrival and is investigating.
