

Medicare Diabetes Prevention Program (MDPP)

Post-Enrollment Timeline

The timeline below can help applicants track what happens after submitting an MDPP Supplier application.

1 Submit the MDPP Enrollment Application for Review



Regional Medicare Administrative Contractors (MACs) receive MDPP enrollment applications online through PECOS.*

3 Complete Additional Requests (if applicable)

MDPP supplier applicants may receive requests for additional information from their MAC (e.g., missing documentation or fingerprints). Supplier applicants should reply in a timely manner to avoid enrollment denial.

Key tips before submitting an application

- Check the MDPP website for helpful resources
- Conduct screenings of individuals that will be reviewed by CMS during the enrollment process (e.g., coaches, owners, and managing members)
- Conduct a thorough review of the enrollment application before final submission

2 MACs Review Submitted MDPP Enrollment Applications



MACs typically require approximately 80-90 days to review an application, but may require more. Processing times are longer if there are issues with the application (e.g., development requests). Contact your MAC to check on the status of or update your application. MACs release development requests when they require additional information or actions. **To avoid development requests**, ensure all information and requirements are completed prior to submission.

4 Receive Enrollment Decision from MACs



MACs will notify applicants once enrollment is approved or denied. Once approved, MDPP suppliers may begin furnishing and billing for MDPP services.
