WHY THESE MARKETS?

A central location within Europe and shared borders with Germany make The Czech Republic and Poland an excellent gateway to Central and Eastern European (CEE) markets. The two countries are the regional leaders in prosperity, stability, market size, buying power, and ease of doing business.

The Czech Republic (population 10.7 million) is the second most industrialized country in the EU after Ireland. Business opportunities exist in numerous sectors:

- **automotive parts and equipment** over 50% of the world's 100 largest auto components manufacturers have a local manufacturing facility there
- **electronics and electrical equipment** the sector is marked by a high proportion of imported materials, components and parts for production and assembly
- **energy & environmental technologies** smart grid, energy storage, e-mobility, waste handling, green energy solutions, smart homes
- **medical technologies** the country boasts one of the most developed biotech sectors
- **IT & IoT & High-Tech Products** CEE awaits massive investments into Internet of Things as the region gears up for digital transformation; cybersecurity solutions are also in high demand

Poland (population 38 million people) is the largest consumer market by value in CEE. A large portion of imports (total of USD 190 billion) is in capital goods needed for industrial retooling and manufacturing. Opportunities exist across many sectors:

- **defense & military** increase of defense expenditures up to 2.5% of GDP by 2030
- **energy and environment projects** power plants modernization, green buildings, air pollution control, asbestos removal plans, railway and road construction
- **chemicals** largest importer of chemicals in CEE, opportunities in supplying technologies and machinery to the Polish chemical industry
- **agricultural machinery & food processing** highly competitive food & beverage sector
- **advanced manufacturing** Poland is part of the development leading to the industry 4.0 era
- **information technologies**
- **infrastructure & intelligent transport systems.**
