School Test Coordinators (STCs) Respond to School Set-up Survey  Each public school STC or non-public school Corporation Test Coordinator (CTC) must be identified as the SAT Test  Coordinator to serve as the contact for 2022-2023 SAT testing. This individual will ensure that testing is administered with fidelity and deadlines are met.	Mid-September 2022	
SAT Test Coordinator Training This optional training, provided by College Board, introduces SAT Test Coordinators to the policies and procedures related to administering the SAT.	November - December 2022	
Services for Students with Disabilities (SSD) Coordinator Training SAT Test Coordinators must appoint a SSD Coordinator in SSD Online. The SSD Coordinator will complete this required training to ensure that accommodations are successfully implemented for the SAT.	November - December 2022	
Submission of Off-Site Testing Plans Schools must submit their plans to test students off site only if they require extra return materials.	Mid-November 2022 – February 7, 2023	
State-Allowed Accommodations (SAAs) and English Learner (EL) Extended Time Request Window Schools must request SAAs and EL Extended Time for any students that require them.	January 9 – February 16, 2023	
Official SAT Practice Training This training provides official SAT practice for Khan Academy, coaching tools, and resources to help students with their SAT experience.	January 2023	
Deadline for Submitting College Board Accommodation Requests in SSD Online Although this deadlines serves to ensure that accommodations are successfully requested, SSD Online does not close; therefore, SSD Coordinators can continue making requests at any time.	January 10, 2023

Access to College Board Test Information Distribution Engine (TIDE) SAT Test Coordinators are provisioned access to TIDE. Any additional staff access must be granted by the SAT Test Coordinator.	Week of January 30, 2023	
Official Online Test Coordinator Trainings - REQUIRED  The official, required online coordinator training that all SAT Test Coordinators must complete becomes available.	Week of January 30, 2023	
Nonstandard Administration Report (NAR) Available The NAR identifies any nonstandard accommodations for students participating in the SAT and becomes available to designated staff in SSD Online.	Week of January 30, 2023	
Shipment of Materials to Support Digital Testing Schools will receive paper materials to support digital SAT administration.	Week of January 30, 2023

Preadministration Window Opens  During this time, students may opt in to Student Search Service®, complete the optional questionnaire, and identify where to send four free score reports. Although preadministration is not mandatory, it is strongly recommended.	February 6, 2023

Primary Testing Window	March 1-3, 2023	
Accommodated Testing Window The NAR lists students who are eligible to participate in the accommodated testing window.	March 1-14, 2023	
Makeup Testing Window  The makeup testing window is designated for students who were unable to test in the primary window or experienced a testing irregularity that requires makeup testing.	April 12-14 and 18-19, 2023	
Student Score Release – Primary Window Scores from the primary testing window are released to students.	Late March/Early April 2023	
Material Delivery and Returns Last day to return any paper SAT answer sheets.	April 28, 2023	
Educator Score Release Scores are released to educators.	June 2023	
Data and Reports Training College Board provides K12 Reporting training to help educators interpret SAT School Day scores.	June 2023
