| Initial Student Results Available in the Centralized Reporting System (CRS) Initial individual students results are available in CRS. No printed copies of Individual Student Reports (ISRs) or student score labels will be shipped to schools.       | March 7, 2023*      | May 23, 2023*              |  |  |
| Final Student Results Available in CRS Final individual students results are available in CRS. Final reports may be downloaded in several formats. No printed copies of ISRs or student score labels will be shipped to schools.                       | April 21, 2023*     | August 1, 2023*            |  |  |
