# COLLABORATIVE RESPONSES TO DOMESTIC VIOLENCE IN RURAL COMMUNITIES

Virtual Conference: October 3-4, 2022

Coordinated Community Responses (CCRs) have been recognized as a best practice in reducing domestic violence since the Violence Against Women Act was enacted over 20 years ago and can be particularly effective in rural communities, where close-knit relationships and highly engaged community members provide an ideal jumping-off point for collaborative efforts. However, with limited resources that must stretch further than their urban counterparts, it can often be a struggle to implement and sustain this approach.

Recognizing this, the <u>Institute for Coordinated Community</u>
Response and the <u>Conference on Crimes Against Women</u>
are coming together to provide critical training and
resources for implementing collaborative, systemic
responses to domestic violence in rural communities

## RURAL JUSTICE COLLABORATIVE

Rural communities face unique challenges that impact their ability to deliver fair and equitable justice. Despite these challenges, rural communities rely on their many strengths to address the needs of their residents.

The National Center for State
Courts, in partnership with Rulo
Strategies, launched the Rural
Justice Collaborative (RJC) to
showcase the strengths of rural
communities and highlight the
cross-sector collaboration that is a
hallmark of rural justice systems.

The work under the RJC is supported by a cross-sector advisory council composed of rural judges along with additional stakeholders in the justice, child welfare, and behavioral health systems. The advisory council guides and identifies innovative programs and practices.

## MENTAL HEALTH FIRST AID FOR RURAL COMMUNITIES

Mental Health First Aid for Rural Communities teaches people how to notice and respond to signs of mental health and addiction challenges with a specific focus on the cultural and environmental factors related to life in rural areas. Mental Health First Aid is a course that teaches you how to identify, understand and respond to signs of mental illnesses and substance use disorders. The training gives you the skills you need to reach out and provide initial help and support to someone who may be developing a mental health or substance use problem or experiencing a crisis. The International Association of Chiefs of Police (IACP), Office of Community Oriented Policing Services (COPS Office), and Center for Evidence-Based Crime Policy (CEBCP) at George Mason University partnered to gather, evaluate, translate, and recommend best and emerging crime reduction practices for small, rural, and tribal law enforcement agencies. This guide presents information on evidence-based policing practices in small, rural, and tribal agencies, which often have different problems and different needs from the large, urban agencies where most law enforcement research is conducted— as well as different strengths.

## RURAL VETERANS AND LOCAL NONPROFITS RECEIVE CRITICAL HOUSING SUPPORT FUNDED BY THE HOME DEPOT FOUNDATION

Many veterans and their families face major housing challenges, often exacerbated by issues related to unemployment, age, and service-related disabilities. ## NEVADA DEPARTMENT OF CORRECTIONS OPENS STATEWIDE REENTRY AND TRAINING HUB

The Reentry, Programs, and Career Pathways facility (RPCP) opened in December 2021 to provide comprehensive supports for individuals reentering the community along with expanded training opportunities. RPCP's newly renovated space—wired for virtual access—enables its reach to extend well beyond its four walls. The Nevada Department of Corrections designed RPCP with accessibility in mind. RPCP provides opportunities for virtual programming to individuals previously unable to attend, including those located in rural facilities and at sites with limited programming staff.

## REDUCING SUICIDE ONE MESSAGE AT A TIME: RESEARCHERS WILL USE HUB TO REDUCE INDIGENOUS AMERICAN SUICIDES

The Institute for Research and Education to Advance Community Health (IREACH) and Washington State University's Elson S. Floyd College of Medicine are developing a hub to reduce suicide burden in Native American populations. There are two aims for the hub: the first aim will focus on screening for suicide risk and implementing Screening, Brief Intervention, and Referral to Treatment (SBIRT). The second aim will compare SBIRT as a standalone prevention strategy to a model called "caring contacts," Caring contacts, in relation to the hub, will take place in the form of 30 text messages over 12 months. The goal is to increase retention as well as social and cultural connectedness.

### **Tennessee Supreme Court Launches Justice Bus**

The Tennessee Supreme Court Access to Justice Commission publicly launched the Tennessee Justice Bus in June 2022. The TN Justice Bus is a mobile law office that brings technology to rural and underserved communities. The TN Justice Bus is a passenger van outfitted with computers, tablets, a printer, internet access, video displays, Wi-Fi, and other office supplies. Lawyers and other volunteers will be able to provide on-the spot access to legal help and meet Tennesseans where they are. The Commission is joining a small network of other states that have launched justice bus projects in response to natural disasters, to connect with rural citizens, or to bring technology to disadvantaged communities.
