The Oregon Public Utility Commission (PUC) is holding a public comment hearing to provide information and to solicit comments on UE 399 PacifiCorp Request for a General Rate Revision. ## **What to Expect**

There generally will be no formal presentations, but members of the PUC will be on hand to answer individual questions and provide information before and after the hearing. We ask that all participants be respectful and courteous.

The event will begin with brief presentations from the Administrative Law Judge and Staff to explain the rate case process.
