Bb. whereas during Evo Morales' mandate, Bolivia experienced significant economic growth unlike the rest of the region, with its GDP consistently above Latin American averages; whereas unemployment levels decreased from 7.7 % to 4.4 % in 2008, following this trend by 2018; whereas during his mandate, the minimum wage in Bolivia rose by 140 %; whereas the redistributive policies of the Government of Evo Morales have lifted 1.8 million people out of poverty since 2006; whereas the number of people living in extreme poverty fell from 38.2 % to 15.2 % in the last 13 years; whereas Bolivia has been a pioneering country in protecting the environment and its laws give judicial character and rights to nature, unlike in any EU Member State;

Paragraph 1

Joint motion for a resolution

1. *Denounces and condemns the arbitrary and illegal detention of former interim President Añez, two of her Ministers, and other political prisoners; calls on the Bolivian authorities to release them immediately and drop the politically motivated charges against them; calls for a framework of transparent and impartial justice free from political pressure, and urges the authorities to provide all the necessary medical assistance to ensure their well-being;*

1. *Takes notes of the arrest of Jeanine Añez and several former officials of her coup government on March 14; expresses confidence that the Bolivian judicial system will solve their case in accordance with Bolivian law; points to the instrumental role Añez played in the 2019 coup as interim president, including by issuing a decree removing criminal liability for police and military in dealing with protesters, and notes the seriousness of the charges pressed against Añez and several formal officials for their culpability in the Senkata and Sacaba massacres; believes that the violent attacks carried out by the military and the police and groups linked to them should be investigated, with those responsible brought to justice, and that reparations should be guaranteed to victims;*
