#### 1. Chair's announcements

#### 1.1 Interpretation

#### 1.2 Possible EMPL input for BUDG MFF INI report [EC]

#### **Decision:**

#### The Coordinators

- bearing in mind that EMPL had previously decided not to give an opinion on the "Next MFF: preparing the Parliament's position on the MFF post-2020".1
- were informed of a request from the BUDG rapporteurs Mr Olbrycht and Ms Thomas that EMPL submit a contribution and that BUDG would adopt its report in February 2018
- decided to apply the procedure laid down in Rule 53(4), that is the adoption of amendments by EMPL committee, the rapporteur being the Acting Chair.

#### 1.3 Retabling of EMPL budgetary amendments [EC]

Rule 88(5) provides:

"5. Amendments tabled in Parliament which have been rejected in the committee responsible may only be put to the vote if this has been requested in writing, before a deadline to be set by the President, by a committee or by a political group or Members

start of the vote." <sup>2</sup>

#### **Decision:**

The Acting Chair announced that the secretariat would circulate an email detailing the practicalities for applying the procedure laid down in Rule 88(5).

Note: That email contained the following elements:

- a table with all the amendments that were rejected in the Committee on Budgets,
- a request to all groups to declare which amendments they endorse, <u>deadline 18 October 10</u>
   <u>a.m.</u>
- a clarification that only amendments receiving support from a number of groups representing a majority of seats (28 out of 55) would be tabled on 18 October at noon on behalf of the committee.

# EMPL delegation to Sofia (week 44) (LS/LE)

At their meeting on 13 July, the Coordinators confirmed that the delegation visit will take place from 30 October to 1 November.

#### **Decision:**

The Coordinators took note of the state of play.

# Organisation of trilogues on the Cedefop, EU-OSHA and Eurofound regulations (JuB/CF/PR)

- in the presence of Mrs Sander, Cedefop rapporteur, and Mr Calvet Chambon, Eurofound rapporteur (Mr Hoc, EU-OSHA rapporteur, was excused) -

#### **Decision:**

#### **The Coordinators**

- heard the Acting Chair who informed them of the state of play following a staff-level preparatory meeting that had been held the day before
- held an exchange of views
- decided that the negotiations with the Council shall be organised in two phases:
  - Phase 1 shall consist of joint trilogues for all three files on the common parts
  - Phase 2 shall consist of separate trilogues for the parts specific to each Agency
- agreed that the conclusion of the specific parts for an Agency was the prerogative of the negotiating team for that Agency
- instructed the Secretariat and the Codecision Unit to submit a paper with practical and methodological information.

# 2. EMPL hearings in the first half of 2018

The papers for the meeting included

- a) a table summarising the proposals received from the political groups
- b) a table allowing the groups to rank their choices
- Annual quota for hearings: 16 reimbursed experts.

### **Decision:**

#### The Coordinators

- held an exchange of views during which the groups indicated their priorities
- decided, on the basis of the support received for the proposals, that the following three public hearings be requested for the first half of the year 2018:
- 1. "Digitalisation and automation: Challenges for the labour market and social security systems"
- 2. "Working conditions in sectors presenting a high risk of exploitation"
- 3. A hearing in the context of the legislative proposal "Work-life balance" (rapporteur Mr Casa).

### Additionally, the Coordinators

- noted that the S&D group had made the proposal to invite Commissioner Thyssen to present the state of play on the future 'European Labour Authority', the envisaged European Social Security Number <sup>3</sup> and on other priorities such as the revision of the Written Statements Directive and
- instructed the Secretariat to explore when would be the best moment for such an exchange of views, taking account of the progress of preparatory work within the Commission. [LS]

# **Decision:**

The Coordinators:

- 1. agreed on the proposed structure and
- 2. Invited the Groups to submit proposals by 9 November noon for
  - Topics to be discussed at the ICM, with draft questions;
  - Possible names of Members of national Parliaments to be invited as speakers on those topics.

Coordinators could agree on the topics and on the questionnaire <u>at their next meeting of 21</u>
<u>November</u> in order for the Secretariat to send the questionnaire to national Parliaments by early December.

# 5. Africa Week - possible items on committee agenda (LS)

The papers for the meeting included

- a letter from President TAJANI to Ms WIKSTRÖM, Chair of the CCC, asking her to invite Committees to participate in this "Africa Week" by discussing a dedicated point on Africa in their respective committee meetings during this week
- a note on a high-level conference on Africa which will be held on 22 November 2017 in Brussels.

## **Decision:**

#### The Coordinators:

- 1) Agreed to allocate a 1 hour slot for this item during the EMPL Committee meeting on 20-21 November.
- 2) Instructed the Secretariat to identify, until 20 October 2017, noon, suitable available speakers (Commission, World Bank, ACP), subject to confirmation by the Coordinators in a written procedure (deadline 24 October COB).

# 6. Experts for the Governing Board of the European Training Foundation (ETF) (BM)

#### **Background**

Regulation (EC) No 1339/2008 of the European Parliament and of the Council of 16 December 2008 establishing a European Training Foundation (ETF) includes in its Article 7 the provision that the Governing Board of the ETF shall "consist of one representative of each Member State, three representatives of the European Commission, as well as three non-voting experts appointed by the European Parliament".

The term of office of the three experts

- Mr Jan ANDERSSON from Sweden (sponsored by the S&D group) will not represent himself
- Ms Edit BAUER, from the Slovakia (sponsored by the EPP group) availability to be verified
- Mr Jean-Francois MEZIERES from France (sponsored by the ALDE group) availability to be verified

who were appointed in February 2015, comes to an end in February 2018.

#### **Decision:**

#### **The Coordinators**

# noted that the procedure would be as follows:

- a) political groups may propose candidates by 16 November 2017 and a shortlist of suitable candidates would be established by Coordinators at their following meeting on 21 November;
- b) shortlisted candidates could be invited for a hearing and selected candidates could be confirmed at the EMPL committee meeting in January 2018;
- c) the Chair would then recommend the appointment of the selected candidates to the CoP;

took note of the Chair's announcement on Mr Andersson's unavailability for a new term of office;

#### decided that

- the Secretariat shall verify the availability of Ms Bauer and Mr Mezieres
- the deadline for submitting proposals for suitable candidates shall be the 16<sup>th</sup> of November 2017, COB.
