SUBJECT

Recommendation to appoint and set the salary for Arlene Barrera to serve as Auditor-Controller for the Office of the Auditor-Controller.

IT IS RECOMMENDED THAT THE BOARD:

- 1. Approve the Chief Executive Officer's (CEO's) request to appoint Arlene Barrera to the role of Auditor-Controller, effective October 29, 2019, at an annual salary of \$310,829.
- 2. Instruct the Director of Personnel to prepare and execute the appropriate agreement with the Auditor-Controller for the Office of the Auditor-Controller.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

It is requested that the Board of Supervisors (Board) approve the CEO's recommendation to appoint and set the salary for Ms. Arlene Barrera to the position of Auditor-Controller. Ms. Barrera has over 33 years of experience working in the Office of the Auditor-Controller and has been serving as the Acting Auditor-Controller since April 2019. Ms. Barrera also served as a Chief Deputy Auditor-Controller and Assistant Auditor-Controller.

It is recommended that the Board appoint Ms. Barrera as Auditor-Controller, effective October 29, 2019, at an annual salary of \$310,829.
