

PURPOSE

The purpose of the Standard Operation Procedure Manual is to set out operating procedures that are clear and concise, and to ensure that the orders, instructions, guidelines and protocols outlined within this manual are in keeping with the highest traditions of the New York State Police.

AUTHORITY

The New York State Police is authorized by Section 215 (11) of the Executive Law to create the Protective Services Unit. Specifically; “such majors, one of whom shall be in charge of the detail assigned for special duty with the governor, as the superintendent may appoint.”

MISSION PRIORITIES

The Protective Services Unit (PSU) provides the following services 24 hours a day, listed in order of priority:

- Provides personal security, pursuant to the New State Executive Law, for the Governor, his immediate family, the Lieutenant Governor and anyone else designated by the Superintendent. The mission is to provide a maximum degree of personal security in a manner that will allow the greatest degree of privacy and freedom of movement for those being protected.
- Protects and secures the Executive mansion, ground, buildings, vehicles, and any other area or building necessary to provide proper security for the Governor.
- Provides transportation and/or makes all necessary arrangements for the transport of the Governor.

NATIONAL GOVERNOR'S ASSOCIATION MEMBERSHIP (NGSA)

The New York State Police belongs to the National Governors Security Association. A reciprocal agreement exists between the security details of all 50 states and United States Territories. This allows for the cooperation from, and the protection of, the Security Details in visiting assignments for the Governors, First Spouses and Lieutenant Governors of the above locations. The United States Secret Service and the Capitol Police provide liaisons for NGSA members to facilitate the dignitary's stay in Washington D.C.

Cuomo Accused of Unwanted Advance at a Wedding: 'Can I Kiss You?'

The young woman's account follows two separate accusations that Gov. Andrew Cuomo sexually harassed two female state employees.

Anna Ruch had never met Gov. Andrew M. Cuomo before encountering him at a crowded New York City wedding reception in September 2019. Her first impression was positive enough.

The governor was working the room after toasting the newlyweds, and when he came upon Ms. Ruch, now 33, she thanked him for his kind words about her friends. But what happened next instantly unsettled her: Mr. Cuomo put his hand on Ms. Ruch's bare lower back, she said in an interview on Monday.

When she removed his hand with her own, Ms. Ruch recalled, the governor remarked that she seemed "aggressive" and placed his hands on her cheeks. He asked if he could kiss her, loudly enough for a friend standing nearby to hear. Ms. Ruch was bewildered by the entreaty, she said, and pulled away as the governor drew closer.

"I was so confused and shocked and embarrassed," said Ms. Ruch, whose recollection was corroborated by the friend, contemporaneous text messages and photographs from the event. "I turned my head away and didn't have words in that moment."



Anna Ruch said she felt "uncomfortable and embarrassed" when Mr. Cuomo placed his hands on her face and asked to kiss her.

Ms. Ruch's account comes after two former aides accused Mr. Cuomo of sexual harassment in the workplace, plunging his third term into turmoil as the governor's defenders and Mr. Cuomo himself strain to explain his behavior.

A spokesman for the governor did not directly address Ms. Ruch's account, referring to a general statement that Mr. Cuomo released on Sunday night in which he acknowledged that some things he had said "have been misinterpreted as an unwanted flirtation."

"To the extent anyone felt that way, I am truly sorry about that," the statement said.

Ms. Ruch's example is distinct from those of the former aides: A former member of the Obama administration and the 2020 Biden campaign, Ms. Ruch has never been employed by the governor or the state. But her experience reinforces the escalating concerns and accusations about Mr. Cuomo's personal conduct — a pattern of words and actions that have, at minimum, made three women who are decades his junior feel deeply uncomfortable, in their collective telling.

Exactly a year after the state's first confirmed coronavirus case — the dawn of a crisis that eventually propelled Mr. Cuomo to national Democratic stardom — the governor was silent on Monday, even as the fallout continued to shadow his beleaguered administration.

His accusers were not quiet, however: Charlotte Bennett, a former aide who accused Mr. Cuomo of sexual harassment, issued her first public statement since outlining her claims in a New York Times article, saying that the apology and attempted explanation issued by the governor on Sunday night was woefully inadequate.

"These are not the actions of someone who simply feels misunderstood," Ms. Bennett wrote. "They are the actions of an individual who wields his power to avoid justice."

Ms. Bennett also called on other women, if they had similar stories about Mr. Cuomo, to come forward. "If you choose to speak your truth, we will be standing with you," she said. "I promise."

At the same time, the initial stages of a pending investigation into Mr. Cuomo's actions were underway inside the offices of the state attorney general, Letitia James, who was evaluating options for an outside investigator.

In the statement released on Sunday evening, Mr. Cuomo addressed his behavior, including "some of my past interactions with people in the office," saying that he had often teased and bantered with his underlings, "being playful" in what he called "a very serious business."

That, he suggested, had been misconstrued.

"I now understand that my interactions may have been insensitive or too personal and that some of my comments, given my position, made others feel in ways I never intended," he said.

A lawyer for Ms. Bennett, Debra S. Katz, cast doubt on the governor's initial suggestion, released in a statement on Saturday night, that his relationship to Ms. Bennett was of a mentor to his employee, nearly four decades his junior.

"He was not acting as a mentor, and his remarks were not misunderstood by Ms. Bennett," said Ms. Katz, who specializes in harassment and employment discrimination and represented Christine Blasey Ford in the Supreme Court confirmation hearings of Brett M. Kavanaugh.


"He was abusing his power over her for sex," Ms. Katz said. "This is textbook sexual harassment."

Indeed, on Monday, Mr. Cuomo's contrition — a rarity in his decade-long tenure — was rejected by some other New York Democrats, including Mayor Bill de Blasio of New York, who said that the governor's statement was "not an apology."

"He seemed to be saying, 'Aw, I was just kidding around,'" Mr. de Blasio said. "Sexual harassment isn't funny. It's serious and it has to be taken seriously."

On Monday night, Representative Kathleen Rice, a former Nassau County district attorney, became the first Democrat in New York's congressional delegation to call for Mr. Cuomo to resign.





The political woes of Mr. Cuomo — already under fire for his handling of nursing homes in the pandemic and his abrasive approach to governance — deepened last week when Lindsey Boylan, a former top economic development official, posted a lengthy essay outlining a workplace environment where “sexual harassment and bullying is so pervasive that it is not only condoned but expected.”

She described a series of uncomfortable interactions with Mr. Cuomo, including an unsolicited kiss in 2018, which the governor has strenuously denied.

Then, on Saturday, Ms. Bennett recalled her own encounters with Mr. Cuomo in the spring, when she said the governor asked her personal questions, including whether she had slept with older men, whether she was monogamous, and whether she thought age mattered in relationships. Ms. Bennett is 25; the governor is 63.

The interactions, which Ms. Bennett described in a series of interviews with The Times, left her certain that the governor was suggesting a sexual relationship.

“I understood that the governor wanted to sleep with me,” Ms. Bennett told The Times, saying she felt scared and upset. “And was wondering how I was going to get out of it.”

For Ms. Ruch, the circumstances were different, her exchange with the governor taking place at a well-attended celebration far from any official setting. In fact, the episode’s highly visible nature made it all the more jarring, she suggested. She recalled Mr. Cuomo moving his hand to the small of her back — exposed in an open-back dress — within moments of their being introduced and shaking hands at the reception.

Ms. Ruch said that touch, on her bare skin, discomfited her. “I promptly removed his hand with my hand, which I would have thought was a clear enough indicator that I was not wanting him to touch me,” she said.

Instead, Ms. Ruch said, Mr. Cuomo called her “aggressive” and placed his hands on her cheeks.

“He said, ‘Can I kiss you?’” Ms. Ruch said. “I felt so uncomfortable and embarrassed when really he is the one who should have been embarrassed.” (A friend captured the exchange in a series of photographs taken on Ms. Ruch’s cellphone.)

Shaken, Ms. Ruch said, she later had to ask a friend if Mr. Cuomo's lips had made contact with her face as she pulled away. The governor had kissed her cheek, she was told.

"It's the act of impunity that strikes me," Ms. Ruch said. "I didn't have a choice in that matter. I didn't have a choice in his physical dominance over me at that moment. And that's what infuriates me. And even with what I could do, removing his hand from my lower back, even doing that was not clear enough."

Unnerved and baffled, Ms. Ruch said, she posed for a photograph with Mr. Cuomo afterward. Once the governor walked away, Ms. Ruch's friend approached her with a look of alarm.

"It was when my friend looked at me and said 'Are you OK?' with such genuine concern in her face that I realized how obviously inappropriate it was," Ms. Ruch said, "not only to me but to those around me as well."

In a text message a day or so later to the friend, Ms. Ruch wrote "I'm so pissed," referring to the governor as "this guy," with an epithet in that description.

After collecting herself later that night, Ms. Ruch said, she had hoped to speak with the governor before he left the reception and confront him about his behavior.

But by then, she said, she could not find him.

"I would have rather just said it that night," she said. "I wanted to say, 'That wasn't OK.'"

Good evening and thank you so much for joining me here.

First, I'd like to thank all of you for your tremendous support over the years. It's because of all of you in this room that last year we made history by receiving more votes than any Governor in history.

And I have such admiration for the folks in this room, because what you have managed to accomplish against entrenched, immovable political forces has been extraordinary.

It's because of your willingness to take on the status quo that the Charter school movement is established and has demonstrated tangible progress for countless children in every corner of this great state.

While many people get involved in the political process for self-interested reasons, you have dedicated your time and money to the Charter movement solely because it is the right thing to do. And, unfortunately, you don't see many ventures in modern politics that have that purity of intent.

We live in a modern political system that is dominated by super-heated extreme forces, and these forces are spreading like a cancer in the body politic. The chaos that is emanating from Washington and certain political circles within our own State is unlike anything I've seen during my time in politics.

That is why your support is more important now than ever before, because we need to restore sanity, we need some moderation, and we need stability at all levels of government. And in New York we've managed to do just that.

Success Academy schools are a clear demonstration of excellence and are positioning our youth for greatness. Don't take my word for it, the numbers say it all.

This year, Success Academy continued its track record of excellence, ranking first in the State on the ELA and Math exams:

- **99% of Success Academy students passed the Math exam**
- **90% of Success Academy students passed the ELA exam**

So, we must continue to support the Charter movement, and this administration has done more for Charter schools than ever before:

- In 2014, **we enacted Charter School Supplemental Tuition** and enacted Charter School facilities Aid in New York City;
- In 2015, **we appropriated \$25 million for direct support to charter schools** through GLOP and authorized failing schools to be restarted as charter schools;
- In 2016, **we increased the direct support to charter schools to \$54.8 million and permanently indexed the charter school funding formula that was frozen;**
- In 2017, **we increased Charter School Supplemental Tuition to \$1,000 per pupil and reformed the charter school tuition formula so that it is based on the multiyear average growth in school district spending;** and
- Last year, **we appropriated \$62.6 million for direct charter school payments.**

When I came into office in 2011, Albany was complete and total dysfunction. They faced a \$10 billion deficit. In 2010, the budget was 125 days late. We'd become a national mockery. Government failed to deliver.

Since then, we have passed nine timely state budgets and each one holds new spending to less than 2 percent. No governor in modern political history has accomplished that.

Once you control state spending, you are able to lower taxes. And we have lowered taxes all across the board:

- Today, we have the lowest corporate tax rate since 1968;
- The lowest manufacturing tax rate since 1917; and
- The lowest tax rate for the middle class since 1947.

And our economy is thriving. Today all arrows are pointed in the right direction:

- The unemployment rate in New York State was 4.0 percent as of August 2019, down from 8.8% in February 2010;
- And statewide, we have achieved a record of over 8.2 million jobs.

We have reclaimed the mantel as the most visionary, daring state in this nation through

bold infrastructure projects that will fundamentally transform New York for decades to come.

We're not waiting for the federal government to pass an infrastructure plan – we're moving forward with projects that have lagged for decades:

- A new LaGuardia Airport
- A new JFK
- A new Kosciuszko Bridge
- New airports and train stations upstate to drive growth, where we need it most
- A new Moynihan Station beside Penn Station
- The new Second Avenue Subway and the largest capital plan in MTA history
- \$6.6 billion plan to transform the LIRR – the largest commuter rail in the nation
- East Side Access, which we are going to finally finish fifty years after Governor Rockefeller and Mayor Lindsay first broke ground.

So after years of dysfunction in Albany, we have turned New York into a model for effective, fiscally responsible government.

At the same time, we have enacted the nation's most progressive laws – proving that you can be socially progressive and fiscally responsible at the same time.

- We passed **marriage equality**
- We passed the **\$15 minimum wage** and the most comprehensive **Paid Family Leave** program in the nation.
- We passed the toughest **gun safety laws** in the nation, including the Red Flag Law that gives parents, teachers and law enforcement the tools they need to keep guns out of the hands of mentally disturbed individuals.
- We have **closed more prisons** than any administration in history and have provided more alternatives to incarceration than ever before.
- We have the strongest **environmental** agenda in the nation, and the largest commitment to renewables, including offshore wind that will transform our state's economy.

And one thing is crystal clear: as we continue to control spending, cut taxes, grow our economy and enact nation-leading progressive legislation, it is critical that the future leaders of New York have an excellent education to meet our growing workforce demand.

Success Academy schools are a clear demonstration of excellence and are positioning our youth for greatness. Don't take my word for it, the numbers say it all.

This year, Success Academy continued its track record of excellence, ranking first in the State on the ELA and Math exams:

- **99% of Success Academy students passed the Math exam**

- **90% of Success Academy students passed the ELA exam**

So we must continue to support the Charter movement, and this administration has done more for Charter schools than ever before.

We made tremendous progress in 2017 when we unfroze the charter school funding formula, and now we must build on that progress.

I believe that this upcoming Legislative session will be truly transformative for the Charter movement, and I hope that the legislature in Albany shares this sentiment when we return in January.

Our greatest challenge is having a sensible legislature that understands the value of charter schools, giving parents a choice for their children's education and providing resources that foster charter school growth so they continue producing excellent results for our children.

While we have provided short-term cap relief in New York City, we also must consider raising the statewide cap on charter schools. That is something that I am working on myself but the political landscape is very difficult, as you all know well.

The same entrenched political forces that have stymied our progress will try to stop us once again. Everyone in this room should think about that, and I will need your help as we head into the New Year.

So, thank you all again for your support. Your selflessness and kind-heartedness has made our state a better place for our children and will have a lasting impact for decades to come.

The future leaders of New York could not be in better hands, and I look forward to continuing our work together.
