Members of the public may appear in-person and participate in meetings of the County of Alameda Board of Supervisors. Alternatively, members of the public may choose to view meetings and participate remotely through teleconferencing. Members of the public who choose remote participation may participate in the meetings and address the Board during the meetings in the following ways.

Public Comment via Teleconference

Members of the public may address the Board of Supervisors regarding matters on the agenda before or during consideration of an item, <u>and</u> during the Public Input portion of the meeting for matters not on the agenda. Matters not on the agenda must be within the Board's subject matter jurisdiction.
