The meeting opened at 09.06 on Thursday, 28 September 2017, with Anneleen Van Bossuyt (Chair) presiding.

1. Adoption of agenda

2. Chair's announcements

A. Proposal for Union Act

The chair informed the Committee that pursuant to Rule 46 para. 2 of the Rules of Procedure, IMCO held an exchange of views with the authors of the proposal on "Differences in the declarations, composition and taste of products in central/eastern and western markets of the EU" on 22 June 2017. Following that meeting, Coordinators decided on 12 July 2017 to inquire with the Commission about its lack of action since Parliament's resolution on a new agenda for European Consumer Policy of 11 June 2013.

Furthermore, the IMCO Chair held a meeting with Commissioner Jourova on 12 September who informed that the Commission was going to present an interpretative opinion of the Unfair Commercial Practices Directive, addressing the dual quality of Products. It has been consequently agreed that the Coordinators would wait for that presentation before taking a decision on a further follow-up.
