
Accessing the LMS:

- 1) Go to learn.tmhp.com.



Note: If you are using a Virtual Private Network (VPN) to access the LMS, you may need to disable it. Once you are connected to the LMS, you can reconnect to your VPN.

- 2) When you are ready to create an account, click **Don't have an account? Sign up here**. A New User Registration window will open.



Note: If you are not ready to create an account, but want to browse the topics that are available in the LMS, click **Click here to browse the LMS**. You will be able to view titles and descriptions of training activities, but please note that this content is not available to unregistered users.

- a) Username: We suggest using your email address.






