Justification

Priority should be given to Member States which have made ambitious commitments to phase out coal and lignite, especially those with weaker economies, because these Member States are facing the most urgent transition needs. The transition speed with respect to coal and lignite can be easily and transparently computed using: a) the official data from Eurostat for the GDP in 2016-2018, b) the past emissions in 2016-2018 of all the coal and lignite plants for each Member State from the EU ETS and c) future emissions in 2030 from coal and lignite plants based on the official commitments each Member State has made in the corresponding NECPs submitted to the European Commission.

Justification

The Just Transition Fund should prioritize the 96 coal and lignite regions in EU-27 because these will be impacted the most from EU's transition to climate neutrality. The impact of this transition will be even greater in those regions among the 96, which already have high unemployment rates. To reflect this, we propose the addition of a new criterion based on the unemployment rates of the 96 coal and lignite regions with a 10% weighting, a share which will be subtracted from the weighting factor of the first criterion on the greenhouse-gas emissions of industrial facilities in NUTS level 2 regions where the carbon intensity, exceeds by a factor of two the EU-27 average.
