27a. Recalls that the right to self-determination is a universal right and is recognised as the right of all peoples to freely determine their political status and freely pursue their economic, social and cultural development, as laid down in Article 1 of both the International Covenant on Civil and Political Rights (ICCPR) and the International Covenant on Economic, Social and Cultural Rights (ICESCR); calls for the EU institutions and Member States to respect and defend the right of peoples to self-determination as well as the cultures, identities, languages and all democratic and peaceful political ambitions of European peoples; stresses that Article 1 of the Treaty on European Union (TEU) states that the EU aims at creating an ever closer Union among the peoples of Europe, in which decisions are taken as openly as possible and as closely as possible to the citizen;
