Regrets, furthermore, that many particularly sensitive legislative acts have been adopted by the Polish parliament at a time when independent constitutional review of laws can no longer be effectively guaranteed, such as the Act of 30 December 2015 amending the Act on Civil Service and certain other acts<sup>31</sup>, the Act of 15 January 2016 amending the Act on the police and certain other acts<sup>32</sup>, the Act of 28 January 2016 on the public prosecution office<sup>33</sup> and the Act of 28 January 2016 - regulations implementing the Act on the public prosecution office<sup>34</sup>, the Act of 18 March 2016 amending the Act on the Ombudsman and certain other acts<sup>35</sup>, the Act of 22 June 2016 on the National Media Council<sup>36</sup>, the Act of 10 June 2016 on anti-terrorist actions<sup>37</sup> and several other acts fundamentally reorganising the judicial system<sup>38</sup>;*
