Notice of Public Meeting to Consider Assembly Bill 617 Community Air Protection Program – Fourth Annual Selection of Communities

The California Air Resources Board (CARB or Board) will conduct a public meeting at the date and time noted below to consider selecting additional communities under the Community Air Protection Program. This item is scheduled for the following date and time:

This item will be considered at the meeting of the Board, which will commence no earlier than 4:00 p.m., February 10, 2022.

Background

California's air quality programs continue to significantly improve public health statewide through various measures such as regional air quality planning, advancements in technology-based solutions, and risk reduction efforts near industrial facilities. However, despite these efforts across the State, certain communities, particularly low-income and communities of color, continue to experience environmental and health inequities from air and other forms of pollution. For example, 91% of the population that makes up the 10% most impacted census tracts, as ranked by the State's "California Communities Environmental Health Screening Tool" (CalEnviroScreen), are people of color.

Communities near ports, rail yards, warehouses, and freeways continue to experience a higher burden of air pollution than other areas due to emissions from mobile sources such as cars, trucks, locomotives, and ships, while many also experience pollution impacts from stationary facilities such as oil refineries, oil and gas operations, chrome platers, and metal recycling facilities. Many rural communities contend with similar impacts as well as agricultural burning, fugitive dust and high pesticide use. Residents in these communities are also more vulnerable to the effects of cumulative exposure, as indicated by disparities in health and socio-economic indicators.

AB 617 (C. Garcia, Stats. 2017, Ch. 136) requires that the Board "shall adopt a

statewide strategy to reduce emissions of toxic air contaminants and criteria air pollutants in communities affected by a high cumulative exposure burden." (Health and Safety Code § 44391.2(b).) The statute also requires CARB to annually consider selection of communities for the development and implementation of community air monitoring systems and/or community emissions reduction programs. In response to this statutory charge, CARB established the Community Air Protection Program (Program). Fifteen communities have been selected by the CARB Board and are currently implementing the Program.

Annual consideration of communities has been a constant since an initial 10 communities were selected in 2018. CARB staff are preparing for a transition year in 2022 to expand the number of communities receiving benefits from the program by applying lessons learned and developing additional actions as part of its statewide strategy. At the Board Meeting on February 10, 2022, the Board will hear staff's recommendations for selection of additional communities into the Program. CARB staff's recommendation is based on statutory requirements, the Board's prior direction, community nominations received to date, lessons learned from communities in the program, and funding levels provided by the Legislature for Program implementation. Future Board items will focus on an update to the statewide strategy, including plans for developing actions to expand program benefits to more communities.

CARB, as the lead agency under the California Environmental Quality Act (CEQA), has reviewed the Fourth Annual Community Air Protection Program Recommendations Staff Report and concluded that the recommendations are exempt pursuant to CEQA Guidelines § 15061(b)(3) because it can be seen with certainty that there is no possibility that the proposed action may result in significant adverse impact on the environment. A brief explanation of the basis for this conclusion may be found in the Fourth Annual Community Air Protection Program Recommendations Staff Report.

Proposed Action

CARB staff will present the Fourth Annual Community Air Protection Program Recommendations Staff Report at the meeting. The Board will act on staff's recommendations for the selection of additional communities for the deployment of air monitoring systems and/or community emissions reduction programs.
